From the Pastor's Study A Message From Rev. Dr. Larry Hayward A Stewardship Message

s you know, many years I will preach three to five sermons in the fall on stewardship, highlighting both the importance of making a financial commitment to the church and the goals the church has in terms of supporting our ministry, facilities, and mission with the commitments we receive. Last year we challenged the congregation for a 7.5% increase and received over 11% to increase our mission giving and to move Casey FitzGerald into a position as Associate Pastor for Christian Formation, Patrick Hunnicutt into a position as Associate Pastor for Mission and Pastoral Care, and to call a new Associate Pastor for Youth and Young Adults. Patrick and Casey have made the bulk of those moves over the past few months, and the Associate Pastor Nominating Committee is on track to call a person for this new position within several months. All is as it should be.



Luke 6:38

To continue on this track, Westminster will need 4.6% more in pledges for 2017 than in 2016. While we all feel this is do-able, it remains a challenge and a commitment. While I am not preaching specific stewardship sermons this year, I want you to know how very important it is for us to continue to support the work of Westminster along the path we have set. I urge you for the sake of your own spiritual growth, your commitment to this church, and for the church's ministry to take seriously your commitment, consider increasing, and if you are new to pledging, join us in this effort. And I urge you to place yourself on a track to tithing, giving ten per cent of your gross income to the work of the church. Many at Westminster (including my wife and I) do this. It becomes very spiritually rewarding both to get there and to keep growing once you are.

I cannot say enough how grateful I am for this congregation, for your continued warmth and receptivity, your maturity, your humor, and most of all the way you seek to live out your faith in this community and world. You bring me much joy.

New Hymnal to be Adopted

After a careful, year-long study, the Session approved a new hymnal for WPC: *Glory to God*, which was published by our denomination in 2013. This new hymnal has 250 more hymns than our current one and is about the same size. Some of the hymns in the former hymnal were seldom sung, and those were replaced, often by hymns that were written fairly recently.

The precise timing for this change is uncertain, but the hymnals will be in place sometime in 2017. Before that happens, members will have the opportunity to purchase a hymnal for the church and dedicate it in honor of or to the memory of someone.

Here are some of the questions that are often asked when a congregation changes hymnals:

Question: What's wrong with the hymnal we have? Answer: We love our blue hymnal. The main reason for the change isn't any particular problem with it, but there are opportunities we'll gain by adopting the new one. For example, Glory to God omits some hymns we seldom or never sing and replaces them with new choices. The ones we like will become our "new old favorites." Some you already know; for example, His Eye is on the Sparrow, Softly and Tenderly, Jesus is Calling, and Mine Eyes Have Seen the Glory are added in the new hymnal.

Question: It seems like we just got the blue hymnals. How often do we change?

Answer: Since 1874, our denomination has published a new hymnal every 19 years on average. The blue hymnal was published 26 years ago, and we've been using it for 23 years. We don't need to adopt a new hymnal just because the national Presbyterian Church has published it, but after careful study, we think this is the right time and the right book for us.

Question: What changes in worship will this cause? **Answer:** We're not planning any worship changes as a result of the new hymnal. Our pastors will continue to choose the hymns for each Sunday based on our church's traditions and tastes, to support the worship themes of the day. We certainly will try some of the new hymns when and if they are appropriate to our services. *Glory to God* also has more music that is useful in other settings, such as children's and retreat worship.

Question: What hymns will we notice are gone?
Answer: Very few. The ones we've used most often are "Jesus Walked this Lonesome Valley," "Savior, Again to Thy Dear Name We Raise," and "The Angel Gabriel From Heaven Came." We hate to see them dropped. But the good news is that we have a license that allows us to print any hymn in the current book and sing them when we like.

Question: What kinds of hymns are added?
Answer: Many of the new hymns reflect the growing diversity of worship styles within our denomination. For example, there are more praise songs and songs from the Taizé tradition. We are in the midst of what's been called the "hymnic explosion," with more new hymns than ever before, and the hymnal authors picked out the best of those that they could find. Some are fantastic, some we probably won't ever sing. The overall mix of types of hymns is almost identical to our current hymnal.

Question: The last hymnbook had some changes in language to make it more inclusive. What kinds of changes in language will we see this time?

Answer: There are very few noticeable changes in wording, and those are intended only to make the hymn easier to sing or bring the hymn back to its historical roots. A few verses on familiar hymns were dropped or added; for example, "Be Thou My Vision" now has four verses, as it did in our previous hymnals.

Any change to the worship material that we use every single week is a matter for serious thought. We've tried to consider this question from every angle and we're confident that this is a good step for our church. If you have more questions, please ask a member of the hymnal task force. We have lots of background we can share with you. And we look forward to singing with you out of Glory to God next year!

An In-Depth Overview of the U. S. Immigration System

Paul Wickham Schmidt, recently retired United States Immigration Judge, will give us a guaranteed-to-be entertaining overview of our immigration system. Who is favored? Who is excluded? Who are the outcasts? Where do the refugees fit in? Judge Schmidt has "seen it all"

and done most of it during his 43-year career in immigration law.

Judge Schmidt was appointed as an Immigration Judge in 2003 and retired in 2016. Prior to his appointment, he served as Chairman of the Board of Immigration Appeals, Executive Office for Immigration Review; served as acting General Counsel of the former Immigration and Naturalization Service (INS), where he was instrumental in developing the rules and procedures to implement the Immigration Reform and Control Act of 1986; and practiced business immigration law with Jones, Day, Reavis and Pogue. He has also served as an adjunct professor of law at George Mason University School of Law and at Georgetown University Law Center.

Paul W. Schmidt received his BA from Lawrence University and his Juris Doctorate from the University of Wisconsin School of Law, where he served as editor of the Wisconsin Law Review. Judge Schmidt has written extensively for the American Immigration Lawyers Association and is a member of the Federal Bar Association, the Wisconsin and District of Columbia Bars, and was one of the founding members of the International Association of Refugee Law Judges. Judge Schmidt was born in Milwaukee, Wisconsin and grew up in Wauwatosa, Wisconsin. He and his wife, Cathryn Piehl Schmidt, have resided in Alexandria, Virginia since 1973. They have two married sons and a married daughter, and seven grandchildren, all living in Wisconsin.

Paul Schmidt's presentation on immigration earlier this year at a WPC Adult Education class provoked a lively discussion. Come learn and join the dialogue on one of the most important issues facing our country and our community of faith.

Justification: Is It Still the Article by Which the Church Stands or Falls?

2017 is the 500th anniversary of the Reformation, which gave birth to the fundamental set of beliefs that make us Protestants—our beliefs about the Bible, grace, sin, and who God is. At the center of those beliefs is the doctrine of justification: that we don't earn God's love, it is given to us as a gift. In the 16th century, this idea became an effective prophetic protest against the theology and practices of the Roman Catholic Church. But a lot has happened since then; is this fundamental doctrine still at the center of what we should believe? Join us at the men's retreat to answer that question!

We are fortunate to have the Rev. James F. Cubie as our leader. He has served with the Reformed Institute of Metropolitan Washington since 2011 as a member of the Company of Teachers, leading seminars and retreats. He is also a frequent lecturer on religion and theology. He received his Master of Divinity degree from Union Theological Seminary in New York City, and holds a Master of Theology degree from Princeton Theological Seminary.

How Do We as Christians Navigate the Seas of Change?

How do we as Christians navigate our engagements with Muslims in the global seas of change? There is so much to learn. Dr. Dodd Simms and Salih Sayilgan challenged us to learn more about Islam; to learn more about how to talk with those who differ from us. How do we share about our faith with those of different faith? A follow-up opportunity on January 8 & 15, 2017 will allow us to hear from Salih's wife, Zeyneb.

How do we as Christians navigate illness on spiritual terms? Dr. Christine Pulchalski challenged us to think about our own "life-meaning;" to explore what underlies our religious convictions as we are caregivers and cope with illness and decision-making over illness.

How do we as Christians find God in trauma? Rev. Ruth Everhart shared her story of sexual violence and challenged us to ask tough questions of "Why me?" "Where is God in trauma?" and to journey with God when pain, suffering and sorrow overtake us. What do we do with anger? Shame?

As I type this we are about to hear from Dr. Francis Collins and from Rev. MaryAnn McKibben Dana. Each adult education class isn't just a teacher in an area of current affairs or health issues but is meant to invite us as Christians to examine our faith journey and call us to response. Wrestling with tough faith questions helps us to navigate the seas of change. These programs, I hope, will offer you the chance to hear how others have navigated through their faith, hope and love. In 1999, the Westminster Session established the Westminster Foundation, creating an expanded role in receiving and administering gifts and bequests to the church. Through investment and continued gifts from our members and friends, the Foundation has grown to just over \$2.1 million and supports all program areas of the church, including music, youth ministry, children's and adult education, capital improvements, and mission work.

Some of the significant and visible ways in which the Foundation has provided support to Westminster include:

- Construction of the courtyard from the Karen Blomberg and David Griffith Memorial Funds, the Michelene Williams bequest, and from the Capital Improvement Endowment account
- Women's, men's, family and youth retreats from the Retreat Reserve Fund
- Youth mission trips from the Klingensmith Scholarship Fund, the Zach Stoltz Youth Mission Trip fund and the Chuck Ramsey Youth Mission Fund
- Ruth Pattyson, Margaret Phillips, and Dulcie Webster Memorial Funds used to purchase the new communion table in the Chapel
- Gil Brown Memorial Fund used to support Children's Ministry and the new murals in Creation Station, and
- Westminster's Music Ministry through the Betsy and Don Fowler Music Endowment Fund, and the Phyllis Gorrell Music Fund.

Recently, the Session approved the designation of the Harriet Grant bequest of \$144,000 to establish endowed accounts in the Foundation for Children's Ministry and Youth Ministry. Additionally, Westminster received an extraordinarily generous gift of \$200,000 to the Foundation from the estate of Jack & Carolyn Allen to further Westminster's outstanding music ministry.

And, as announced during a *Minute for Mission* this past July, the Westminster Foundation Board laid out plans for our Planned Giving effort to help our congregation become more aware of the Foundation and this effort moving forward.

Planned giving through the Foundation builds for the future of the church and can be given by members from their assets now and in the future. Some donors make endowed gifts, which preserve the principal and generate income from interest and dividends while other donors give the church discretion to spend the entire gift. Some gifts are given in a one-time donation, while other gifts are provided as a memorial to honor family members or friends. Gifts can be directed by the donors to specific program areas.

While some give to the Foundation through their wills and estates, there are many other opportunities to support the work of the Foundation both now and in the future including cash gifts, retirement funds, bequests and charitable trusts. How we continue to serve our wonderful congregation, the Alexandria community, our nation, and throughout the globe will depend greatly on our collective and continued contributions to the Foundation.

Our stewardship theme for this year is "Share Abundantly," and it comes from Paul's second letter to the Corinthians, Chapter 9 verse 8, when he writes: "God is able to provide you with every blessing in abundance, so that by always having enough of everything, you may share abundantly in every good work." I can't think of a verse that more perfectly describes Westminster. Our rich blessings truly enable us to share Christ's love with the wider community around us, and meeting

this year's goal will allow us to do that in several new ways, including completing our staff reorganization, and strengthening our mission programs, and continuing to care for our buildings and grounds and fund the worship, education, and fellowship ministries that make Westminster such a special Christian community.

This year, we want to invite the congregation to think about what it means for us as Christians to "share abundantly" through our gifts to the church. For many at Westminster, it means making a pledge – an annual financial commitment that we make in the fall and pay over the course of the next year. Pledging helps our session plan and set a budget, but it has a spiritual purpose, too. I invite you in the weeks ahead to think about what "share abundantly" means for you in a personal way.

In order to meet the budget goal set by our session, we need an increase in pledge income for next year of 4.6%. If you've never pledged before and want to learn more about it, or have questions about tithing, please don't hesitate to contact me, Larry, Patrick, or Casey, or one of the other church leaders. Pledges from our whole church community are what allow Westminster to share abundantly the love of Christ in our community, nation, and world, and last year was very exciting as many of you increased your pledges and dozens pledged to our church for the first time. As we work to meet our goal, we ask you to prayerfully consider how you can "share abundantly" through your pledge, and our prayer is that your generosity will deepen your relationship with Christ, and with our church community.
