#### Downtown Presbyterian Church Committee on Saturday Breakfast and Clothes Closet June 23, 2019

The meeting was opened at 12:24.

In attendance were: Rev. Mike Wilson, Claire Armbruster, Dave Coleman, Anil Kuncha, Jeff Koontz, Erin Bell, Faye Dickson, Jim Dickson, Chris Leonard, Pam Swoner, Michael Korak, and Vickie Coffin.

Reading of Genesis 1:26-31 and words of prayer.

Dollars and Cents Expenses have been high year-to-date May 2019. Will use up 12-oz Styrofoam cups until we run out. We will try to limit cup use.

The waiting line for coffee is slow. Self-serve sugar seems to run out faster. Suggest setting up two sugar bowls, two creamers, two coffee rows. Maybe put a bowl of sugar beside the grits, but this might cause confusion with our guests. Maybe invest in coffee containers to be put on dining tables.

We can revise the budget if needed. 12 oz. sugar dispensers are \$1.50 and can be put on tables.

#### Grace on a Plate

Previous partners for Wednesday Lunch wish to use DPC space for weekday lunch for the homeless and urban poor. Use of building only. Volunteers and supplies will be provided along with a hired security team. Discussions are ongoing.

#### Are supplies adequate and well organized?

More hot food wanted. Must request more of The Cookery. Portion control is needed. Summertime is busier than wintertime.

Dave Coleman will speak to Brett Swayn of Lambscroft Ministries/The Cookery about this.

Try to keep help in the kitchen so Anil isn't overwhelmed.

#### The Aggressive, Disruptive Guest

Open Table training will be scheduled for Sunday, October 13, at 12:30 PM. The Fishes and Loaves People will provide a baked potato bar for trainers and trainees. Potatoes will bake nicely in the DPC kitchen. Potato toppings will be brought in.

#### Is it OK to video the presentation?

Vickie Coffin to check on the date/time with Dena Swoner (DPC Office Manager), Mary Turner (Hospitality Committee), Titans game schedule, and Lindsey Krinks (Open Table). Invite everyone who might be interested, including all friends and members of DPC as well as Saturday Breakfast volunteers from outside organizations.

In the meantime, if disruptions occur now: Don't touch angry guests, stay calm, don't escalate, say that you are calling the police (615.862.8600 in non-emergency cases).

#### **Clothes Closet Processes**

The Clothes Closet is out of space. A storage space is needed for excess and out-of-season clothes. Michael Korak suggests using space on the 4th floor.

Erin Bell suggests that donations that can't be used by the Clothes Closet should be taken to Thrift Smart on Nolensville Road for credit for DPC.

Erin is concerned about exceeding the 2019 budget. Lots of discussion about how to balance expenses with incoming donations that have been designated for Clothes Closet. According to Jeff Koontz, DPC Treasurer, when people designate donations to the Community Assistance Fund or Clothes Closet, we will honor that designation.

Erin will lead a fundraiser for the Closet.

A couple of Girl Scouts want to take on the Closet as their service project, spiff up the space.

How to draw attention to specific items we need? Shift the focus to what we've done, more than what we need.

Keep rest rooms tidy. There are showers for the homeless on Union St. Mobile showers and laundry are available.

#### Open Discussion

Codes limit of 150 people in Fellowship Hall. Suggestion to pause the line when 130 guests have been counted. When a few people leave, more may enter. This may help alleviate tension.

Children should not be standing at the door with ticker. It should be an adult volunteer. Mike Wilson will explain the new process on next Saturday morning. It's important that guests stay off the sidewalk.

A guest threatened to burn the church down. The Fellowship Hall is overcrowded, and people have backpacks. Guests are afraid. Erin asks for answers to address the systemic issues of the homeless.

Be aware that gates have been locked with guests still inside the gate and outside the building.

The meeting ended at 2:07 PM.

# FACILITY MANAGER'S REPORT JUNE/JULY 2019

1. The Chapel is 85% remodeled (just my approximation). Yet to be accomplished;

Balcony pews removed and chairs put in place Lighting enhancements to provide greater flexibility in illumination Pocket doors adjusted and lubricated to make functional again Touch-up painting of baseboards and quarter-round Eventual decorating elements to brighten room

2. Iron gate vandalism repair to be completed week of 7/23 Sidewalk blocking permit needed to obtain permission for truck to reach fence for welding work.

3. The 1828 fire-surviving Bible has been relocated to a display case in the History Room. It is set upon the antique adjustable mahogany/ wrought iron book stand. A few assertional items will be place in the new case. Descriptive cards will relate the items' history.

4. Kitchen has been completely re-lit with no-ballast LED tube lamps. Brighter, cleaner appearance (so much so that Paulino had to scrub all the cabinet and drawer fronts because the dirt stood out so much :-)). Best of all, a 55% saving of electricity.

5. We are continuing to have significant parking problems. Not just because of the reduction of available space from the construction at the Cohen Building, but also the increase of contractor's, deliveries, visitor vans when groups come for tours. The parking lot rules and restrictions need to be reviewed and modified to reflect our current level of need. Addressing the parking regulations for AA meeting attendees, Contributor staff, volunteers, and vendors, artists and their personal guests, etc.

6. Wedding coordination needs to be addressed and a better approach to quality service should be established. Communication seems to be the biggest issue. Who is setting the schedule and organizing the elements of the event. Yes, we had a very dedicated and highly efficient individual responsible for all of the details, but Betty did not groom a successor to fully fill her shoes.

# LED LIGHTING RETROFIT PROPOSAL REQUEST FOR APPROVAL TO PROCEED

As part of this year's Capital Project list it is time to address the energysaving investment of LED fixtures to eliminate fluorescent lighting.

The replacement fixture that is most suited to replace our surface mount units has a curved diffuser and uses three LED strips inside. A sample of the unit is installed in front of the small elevator in the hallway between the offices and hallway to the entrance of the chapel. It is a warmer tone and more esthetic unit than the other sample that is installed in the hallway immediately in front of the main entrance of the chapel.

The illumination output of the fixture is considerably more than the currently installed fluorescent fixtures that you can compare in the same area. As a result, we will be able to eliminate a percentage of the fixtures overall and still gain brightness. A 2-for-1 exchange, in certain but not all areas. The LED fixtures consume 50% leads energy than the old units, have a 10year guarantee on the replaceable LED strips, and in some cases, such as offices, will be dimmable if desired. And will provide a project ROI of approximately 5 years used on current NES rates and consumption statistics.

The current plan is to replace the fluorescent fixtures in 3 Phases. First the offices, rooms and hallways on the first floor. Second phase would be the Fellowship Hall. And the third phase of this fixture exchange will be the rooms and offices on the second floor.

Together the three phases will eliminate 100 fluorescent fixture replacing them with approximately 60 LED fixtures.

The total cost for the three phases of replacement will be \$13,000 +/- 10% depending on exactly how many fixtures are replaced and how many dimmers are chosen to be installed.

This cost includes; Existing fixture removal and disposal Installation of outlet box cover plates where fixtures are eliminated Cost of new fixtures Installation of new fixtures This cost does not include; Altering or extending any switching legs Dimmers as determined Replacement or repair of any ceiling tiles

Upon approval of the project, each phase would be completed in a given month beginning in August and completing in October. This would defray the expenses over a 3-month payment period. However, the purchase commitment on the LED fixtures would be an initial 60 units for purposes of quantity pricing. Delivery of the fixtures would be scheduled over the 3-month period as well as the labor.

#### For the bulletin and E-votion

On Saturday, September 28, Second Presbyterian Church and The Downtown Presbyterian Church will co-host a day with John Bell at Second Presbyterian.

John is a Scottish hymn-writer and theologian with 18 credits in our hymnal, Glory to God. He's also Church of Scotland minister and longtime member of the Iona Community. In addition to several volumes of hymns and songs, John has also published books on the teaching and renewal of congregational singing, collections of liturgies, and biblical studies.

His ecumenical work deeply engages issues of social justice throughout the world. Recent efforts have taken him to South Africa, New Zealand and Australia. He regularly travels to churches and conferences in the UK, US and Canada. His primary passion is the renewal of congregational worship at the grass roots level.

While in Nashville John will conduct two Saturday sessions. The first will be on congregational singing in which we'll learn by doing. Using methods honed over thousands of sessions, John will have us singing in ways we might not think possible. He'll also make a case for congregational song as an indispensable centerpiece of worship and why not only *can* everyone sing, but why we must.

The second session will be based on his book *Ten Things They Never Told Me About Jesus: A Beginners Guide to a Larger Christ.* John will explore facets of the personal life, relationships and ministry of Jesus which are seldom the stuff of preaching or conversation, but which are all rooted in the Gospels and are necessary if we are to be freed from the passive stereotypes which still dominate thinking about Christ.

The Saturday sessions will begin at 10:00 a.m. and conclude at 4:00 p.m. with lunch in between.

On Sunday, September 29, John will speak in worship at Second Presbyterian but DPC folks are more than welcome to worship there if they are so moved.

As co-sponsors of the event, DPC will be responsible for providing lunch between sessions on Saturday. For more information see Worship chairman David Maddox or Rev. Mike.
