Motion from Ms. Kellar with second from Mr. Coleman to explore options with the hope of providing live streaming worship on Sundays at 11:00; this is to be a synchronous experience; a task of the Communications Committee (CommComm) along with the Worship Committee; the motion carried. **Motion** from Mr. Maddox with second from Ms. Coffin to task the Pastor along with CommComm and the Worship Committee with creating virtual small groups of DPC family and friends; the small groups are to be led by elders (or others); the groups will commune and provide care, support, nurture to each other; the motion carried.

Motion from Mr. Coleman with second from Ms. Gentry to have Saturday Breakfast supplies delivered to The Cookery, where they will be assembled into paper bags to be picked up by DPC volunteers; the bags are to be distributed outdoors on DPC property by a few volunteers; the process is to be reassessed by the Session each Thursday during its virtual meeting; the motion carried.
