*Because of the last-minute change of venue, and the all-new conditions of meeting, including the unknown dangers of the pandemic, the Committee on the Office of the General Assembly... proposed that the 224th GA consider **only business deemed “core and critical to our governance and ecclesiology.”***

They asked these questions in devising an abbreviated agenda for the GA:

- **Is it so time-sensitive that we need to address it now?**
- **Might it have a negative impact on the church financially?**
- **Will it leave critically important leadership positions vacant?**

In other word:
***The original docket only included
these things.***

THAT WHICH CANNOT BE DEFERRED

FINANCIAL ISSUES: REVENUE, FLEXIBILITY, PERSONNEL

ASSURING CONTINUED LEADERSHIP

BUDGETING IMPLICATIONS FOR PCUSA

- *A BUDGET IS A PLAN. THE LACK OF INFORMATION ABOUT AN UNKNOWN FUTURE CREATES HUGE PROBLEMS FOR BUDGETING.*
- *BECAUSE OF THE COVID-19 PANDEMIC, THE CHURCH EXPECTS DEEP REDUCTIONS IN OPERATING REVENUES.*
- *THE LEADERS IN LOUISVILLE NEED EXPANDED FLEXIBILITY IN BUDGET PLANNING AND SPENDING AUTHORITY IN THE COMING TWO YEARS.*

Budget Realities at PCUSA

- *Presbyterian Mission Agency is projecting a 25% revenue drop in 2020 and 2021, with a 20% reduction in 2022.*
- *The Per Capita Budget is expected to have a 35% reduction of income in 2020 and 2021, including uncollectible per capita.*
- *The Administrative Services Group will be affected by cuts from both Mission and Per Capita Budgets.*
- *That the apportionment rate for 2021 and 2022 remain where it is now, at \$8.95.*
