

# Pulpit Supply List

This list is provided as a service to the congregations of the Presbytery of Wabash Valley that are seeking temporary pulpit supply.

Compensation recommendaiton from the Commission on Ministry (COM) for those requesting pulpit supply:

- \$100 for one service;
- \$150 for two services within four hours;
- \$100 to moderate 1st monthly session meeting;
- \$ 50 for subsequent meetings within the same month.

Mileage reimbursement at the IRS rate of .575 for travel greater than 20 miles round trip.

Only ordained elders and ministers are approved. Ruling Elders who desire to be listed for preaching opportunities should first request their respective Session to endorse them and provide that letter to Commission on Ministry (COM). All who wish to be added to the pulpit supply list are expected to meet with COM. To remain on the pulpit supply list, each must submit annual ministry reports and attend Boundaries and Ethics Training.
