Boulevard Presbyterian Church is located just outside downtown **Columbus, Ohio in the Grandview Heights neighborhood.**

If driving in from the North, take 315 South to 670 W. Exit at Grandview Ave., turn right on Grandview and it to the West 2nd Ave. stoplight. Turn right on West 2nd Ave. and go down a few blocks. Boulevard Presbyterian Church is located on the left with our parking lot just to the right.

If traveling from the South, take 315 North to 670 W. Exit at Grandview Ave., turn right on Grandview and it to the West 2nd Ave. stoplight. Turn right on West 2nd Ave. and go down a few blocks. Boulevard Presbyterian Church is located on the left with our parking lot just to the right.

If traveling from the West, take 270 South to 70 East. Merge onto 670 East toward the Airport, and take the Grandview Ave. exit off 670 West. Turn Right onto Grandview at the light and take Grandview Ave. to the West 2nd Ave. intersection. Turn right on West 2nd Ave. and go down a few blocks. Boulevard Presbyterian Church is located on the left with our parking lot just to the right.

If traveling from the East, take 270 South to 70 West. Take the 315 North exit and proceed on 315 North until the Goodale/Grandview Heights Exit. Turn right on Goodale and until you come to Northwest Blvd. Turn right on Northwest Blvd. and drive about a mile until you reach West 2nd Ave. Cross Northwest Blvd. to turn left on West 2nd Ave. Boulevard Presbyterian Church will be on your right and our parking lot will be on your left.

Parking Instructions: There are many parking options for Worship and events at Boulevard Presbyterian Church. Our main parking lot is located off West 2nd Ave. and Handicap Designated parking spaces line the side closest to the church. Parking is also available along Northwest Blvd., West 2nd Ave. and Hope Ave.

COMMISSIONER ORIENTATION

So, This Is Your First Presbytery Meeting!

As a new commissioner to the Presbytery, we welcome you! The information below is provided for your orientation to the presbytery meeting and its activities. The meetings of Presbytery are designed to provide opportunities for the community to worship and discuss issues together, as well as do the necessary Presbyter business. Please read the introductory items in the handbook. These items contain information about parking, childcare, directions to the meeting, how to make motions if you wish, and information on parliamentary process.

When you arrive, look for the registration area, which opens prior to the meeting or any pre-Presbytery forums. Commissioners will be asked to register their attendance by signing next to the church they are representing. Commissioners will receive a name badge which entitles them to voice and vote during the meeting. Visitors are also asked to sign in and receive a guest tag. There will also be a table with additional handouts not submitted in time to be published in the Commissioner Handbook.

There may be one or more pre-Presbytery forums which will usually begin one hour before the Presbytery meeting. The forums are small group opportunities to discuss topics coming before the Presbytery, to explore ministry tools, to share best practices, or to engage in the ministry of prayer for the Presbytery. There will be directions to the forums. Also available during the registration time may be a number of displays.

Presbytery meets from 3:30 to approximately 7:30 p.m. The meeting will begin with worship designed by the Presbytery worship committee. A worship bulletin will be in the registration area. There will be an offering which will be designated for one of the Presbyterian Church (U.S.A.) seasonal special offerings.

Following worship, the Presbytery moderator will

- convene the meeting and invite greetings from the host pastor,
- ask the stated clerk if there is a quorum present,
- ask for the introduction of new ruling elders, teaching elders, and corresponding members (members of other presbyteries, congregations, or organizations,
- call for the adoption of the agenda for the meeting, and
- ask the stated clerk if there is any new business not previously included in the published agenda.

Most of the business for the Presbytery to consider is contained in this handbook. The materials are divided into several sections for easy access. The sections are arranged according to the Commissions and reporting entities of the Presbytery, not the order of the agenda. The sections are:

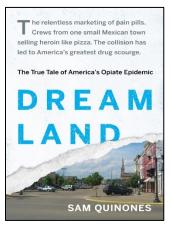

GUIDELINES FOR PARTICIPATING IN PRESBYTERY MEETINGS

- 1. When speaking at Presbytery, please use the microphone and speak to the Moderator not the assembly.
- 2. Introduce yourself, by stating your name and your church or your position.
- 3. The parliamentary authority is *Robert's Rule of Order Newly Revised, 11th Edition* (2011), unless the *Book of Order* (Presbyterian Church (U.S.A.) Constitution Part II) or the Standing Rules of the Presbytery provide otherwise.
- 4. Motions presented by commissions or committees do not require a second.
- 5. Each speaker during debate has up to three minutes to address the issue to which they are speaking. The moderator may give a 30-second warning, so that speakers may conclude their remarks.
- 6. The moderator will normally alternate between speeches for and against the motion before the assembly.
- 7. The maker of the motion or commission/committee presenter may make the final speech.
- 8. Only enrolled commissioners (ruling elder commissioners, teaching elders, commissioned ruling elders, certified Christian Educators in active service, and ruling elders serving on commissions) are authorized to vote. Corresponding members are entitled to address the Presbytery. Visitors may be invited by the moderator to address the Presbytery.
- 9. Any substantive motion (new, amendment, substitute) made by a commissioner in the assembly must be given to the stated clerk in writing, at the time the motion is made.
- 10. Any new business must be placed in the hands of the stated clerk prior to the beginning of the meeting.

Guidelines for Presbyterians During Times of Disagreement

In a spirit of trust and love, we promise we will...

Give them a hearing...listen before we answer (John 7:51 and Proverbs 18:13)

1 Treat each other respectfully so as to build trust, believing that we all desire to be faithful to Jesus the Christ;

_ we will keep our conversations and communications open for candid and forthright exchange,

we will not ask questions or make statements in a way which will intimidate or judge others.

2 Learn about various positions on the topic of disagreement.

3 State what we think we heard and ask for clarification before responding, to be sure we understand each other.

Speak the truth in love (*Ephesians 4:15*)

4 Share our concerns directly with individuals or groups with whom we have disagreements in a spirit of love and respect in keeping with Jesus' teachings.

5 Focus on ideas and suggestions instead of questioning people's motives, intelligence or integrity; _ we will not engage in name-calling or labelling of others prior to, during, or following the discussion.

6 Share our personal experiences about the subject of disagreement so that others may more fully understand our concerns.

Maintain the unity of the spirit in the bond of peace (*Ephesians 4:3*)

7 Indicate where we agree with those of other viewpoints as well as where we disagree.

8 Seek to stay in community with each other though the discussion may be vigorous and full of tension;

_ we will be ready to forgive and be forgiven.

9 Follow these additional guidelines when we meet in decision-making bodies:

_ urge persons of various points of view to speak and promise to listen to these positions seriously;

_ seek conclusions informed by our points of agreement;

_ be sensitive to the feelings and concerns of those who do not agree with the majority and respect their rights of conscience;

_ abide by the decision of the majority, and if we disagree with it and wish to change it, work for that change in ways which are consistent with these Guidelines.

10 Include our disagreement in our prayers, not praying for the triumph of our viewpoints, but seeking God's grace to listen attentively, to speak clearly, and to remain open to the vision God holds for us all.

STATED MEETING

The Presbytery of Scioto Valley of the Presbyterian Church (U.S.A.) held its two hundred forty-fourth Stated Meeting at First Presbyterian Church, Waverly, Ohio, on Tuesday, September 19, 2017.

 - iv. Approved offering a twelve-month grant in the amount of \$1,000 per month from the Greater Marion Ministry Fund to partner with the Lee Street Presbyterian Church to support them in a year-long pilot project for a year of study and planning for a new direction in ministry, with the understanding that the strategy team of the commission will provide coaching to the leadership team of the church in order to present a plan for ongoing ministry, mission, and congregational development in greater Marion; and with the understanding that additional funding may be available through the Commission for Congregational Life if the congregation shows evidence of movement in the direction of the plan and the plan seems to offer benchmarks and milestones which are achievable.

NOTE: The Commission for Presbytery Operations declined to create the Greater Marion Ministry Fund but granted \$6,000 in 2017 and \$12,000 in 2018 from the Church Development Fund to enable the Marion Lee Street pilot program.

The Consent Agenda was approved on voice vote.

Committee for Presbytery Nominations

Committee Chairwomen Carla Mavis presented the names of Sarah Juist (TE) for an unexpired 2018 term on the Commission for Church Professionals, Natalie Alter (RE) and Allison Bauer (TE) for unexpired 2018 terms on the Commission for Congregational Life. There were no nominations from the floor and the nominees were elected on voice vote.

Ms. Mavis put the name of Sally O. Robinson to fill the unexpired 2019 term as Stated Clerk. There were no nominations from the floor. Ms. Robinson was elected by voice vote.

IV. TO SUPPORT LEADERS

COMMISSION FOR CHURCH PROFESSIONALS

Donald Hilkerbaumer reported for the Commission.

Commission member Ann Melick introduced Jeff Schooley, who is pastor of the Marysville First Church.

Stated Clerk Richard Hays presented David Faulkner for recognition of Honorably Retired. The moderator led the Presbytery in a litany of celebration.

Columbus Broad Street Church pastor Amy Miracle presented a memorial moment for the Rev Gerald Gregg who died August 23, 2017.

Commissioned pastor Liz Tietz recognized Ginny Shanda who had completed the presbytery's requirements for being a certified ruling elder. The moderator led the presbytery in a litany of recognition.

Mr. Hilkerbaumer presented the 2018 Minimum Terms of Call for adoption.

Ministers:

Cash and Salary Housing/Utilities – \$48,000* Automobile Reimbursement – IRS Rate† Pension/Medical/Disability – 37% of Effective Salary + Continuing Education Allowance – \$1,000 Annual Study Leave – 2 Weeks Annual Vacation – 4 Weeks

* This represents a 1.0% increase over the 2017 minimum.

† The IRS Rate for 2018 will be announced in December 2017

+ The Board of Pensions dues for installed pastors will be 11% pension, 1% disability, 25% medical; the medical portion has increased by 0.5%

Commissioned Ruling Elders (CRE): The minimum salary and housing terms for a full-time CRE is 80% of the above rate, or \$38,040.

Certified Church Educators: The minimum salary and housing terms for certified church educators is the same as for ministers.

Transitional Pastors: The minimum salary and housing terms for transitional pastors is 90% of amount of the pastor who has just left, but not less than the presbytery minimum.

Full-time and Part-time Positions: A full-time position constitutes a range of 40-48 hours/week. Part-time positions of any kind are pro-rated.

Session Moderators: The honorarium for session moderators is \$50, plus mileage (IRS rate).

Pulpit Supply: The honorarium for pulpit supply is \$100 for one service, or \$150 for two services, plus mileage at the IRS rate.

Contract Pastor Service: The contract rate for pastoral care services is \$25 an hour (including travel time) plus mileage at the IRS rate.

The motion was approved.

Commissioned Pastor Liz Tietz presented the revised Certified Ruling Elder policy for adoption. The policy was adopted on voice vote.

Ann Melick and Rebecca Tollefson presented for first reading the Healthy Boundaries policy. The policy will be voted on at the November meeting.

Todd Tracy introduced candidate Scott Schnapp to be examined for ordination as a Minister of Word and Sacrament. He presented a portion of his statement of faith. Commissioners asked questions. A motion was made and approved to arrest the examination. The presbytery voted to sustain the examination and welcomed Mr. Schnapp to the ministry.

V. TO SUPPORT CONGREGATIONS

COMMISSION FOR CONGREGATIONAL LIFE

Christine Burns reported for the Commission. She presented the policy for the Pastor Nominating Committee Recommending Temporary Pastor as Pastor. The policy was adopted by a standing vote. (Attachment 5)

ADMINISTRATIVE COMMISSION FOR THE COLUMBUS COVENANT PARISH

Mark Shanda presented the report for the commission. On behalf of the commission he moved that the Shady Lane Church be dissolved and that the Fairmoor Church be renamed as the Covenant Parish of Fairmoor and Shady Lane. The motion was approved.

Mr. Shanda moved that the Commission be suspended for 18 months while the session works through the process. The motion was adopted.

Lee Platt moved that the presbytery express its gratitude to Mark and Ginny Shanda for all that they have done for the Presbytery in their involvement with it and wish them the best as they take up new work in Lexington KY. The motion was approved on acclamation.

COMMISSION FOR NUTURE AND OUTREACH

Mary Gause reported for the commission, sharing upcoming dates and events.

There will be a pre-presbytery event at the November presbytery meeting with an online interview with the author of *Dreamland*, Sam Quinones.

Steve Brand presented for first reading the Child Safety Policy. The policy will be voted on at the November meeting.

COMMISSION FOR PRESBYTERY OPERATIONS

Robert Gustafson reported for the Commission. On behalf of the Commission he presented the audit report of HW & Co. for 2016 to be received by the Presbytery. The motion was approved. (Attachment 6)

On behalf of the Commission, Mr. Gustafson moved that the Presbytery adopt the new presbytery bylaws. The motion was approved by the required two-thirds majority. (Attachment 7)

Mr. Gustafson presented the first reading of the 2018 Presbytery Operating Budget. The budget will be presented for adopted at the November meeting.

Dr. Harsh introduced Waverly Church Clerk of Session Elaine Zingg who represented the congregation to celebrate the congregational ministry of Richard Hays at the Waverly Church on the occasion of his retirement from the congregation and from the presbytery.

On behalf of the Presbytery, Dr. Harsh, Moderator Ramsey, and Commission for Presbytery Operations chair Robert Gustafson presented Mr. Hays with gifts to celebrate his ministry and then led the presbytery in a litany of retirement.

Report of the Actions of the Commission for Nurture and Outreach

Pursuant to the authority granted by *The Book of Order,* "Form of Government" Chapter 3, (G-3.0307), Presbytery Standing Rule G-1, and Presbytery action, the Commission has taken the following actions:

1. A Second Reading of the Child Safety Policy Recommend it's approval

Child Safety Policy Presbytery of Scioto Valley

Revised and approved by the Presbytery of Scioto Valley xx/xx/xxxx

The members of the Presbytery of Scioto Valley believe that we are called by God to create a safe place for all the children and youth in our care, nurturing, protecting, and empowering them through faith and trust. This commitment includes taking appropriate steps to reduce the risk to the young people in our care. The following policy, to be implemented for Presbytery sponsored event, is intended to minimize the risk of any of our children being subjected to sexual, physical, or mental abuse. These policies and procedures are also intended to respect the rights afforded due process to person accused of improper conduct. This policy is intended for Presbytery-sponsored events only, and shall not replace the Book of Order mandate that particular churches shall adopt their own child=protection policies and procedures according to G-3:0106.

Definitions

1. Child means anyone under the age of 18 and/or any adult who is developmentally disabled.

2. *Child safety and protection* means "preventing physical, mental and/or emotional injury to a child, including the prevention of sexual abuse."

3. *Leader/Leadership* means any person providing his or her time or services to the presbytery with or without compensation, including keynote speaker, music leadership, small group leader, and all other volunteer leadership or paid leadership, at events in which children or youth are in attendance or in circumstances in which he or she will come into contact with children or youth as part of the service offered.

4. *Chaperone and Advisor* means any person providing his or her time or services to their congregation or the presbytery, both paid and unpaid, to oversee and lead their congregation's children and youth at a presbytery sponsored activity.

5. *Child Care Workers* means any person providing his or her time or services to provide child care, nursery care, or babysitting for children both paid or unpaid for a Presbytery sponsored activity.

4. *Work with children* means teaching, supervising, chaperoning, or otherwise serving in a class, program, or event involving one or more children.

6. Activities mean classes, programs or events presented or sponsored by the presbytery.

Screening and Selection of Leadership:

1. All leadership must complete a consent for a criminal background check unless they can provide documentation that a background check has already been completed by their congregation or governing body. These forms will provide provided personal and confidential information necessary to preform criminal background and reference checks.

2. The background screening will be completed by the designated Presbytery staff person. The forms will kept on file at the Presbytery of Scioto Valley. The results will be reviewed by a Presbytery of Scioto Valley staff person, on behalf of the appropriate presbytery commission, and may be reviewed by the moderator of that committee or task group concerning the result of any background check.

3. Whether disclosed voluntarily or by the result of the background check, the following items will automatically disqualify a person from participating in leadership of activities involving children with the Presbytery of Scioto Valley:

Any conviction for: murder; aggravated assault; sexual abuse; sexual assault (rape); aggravated sexual assault; injury to a child; incest; indecency with a child; inducing sexual conduct or sexual performance with a child; possession or promotion of child pornography; the sale, distribution, or display of harmful materials or prohibited substances to a minor; employment harmful to children; or abandonment or endangerment of a child. All other convictions or charges for any other crimes not listed above will be reviewed by the appropriate committee seeking to secure the particular employee or volunteer.

Screening and Selection Chaperones and Advisors:

1. The Presbytery strongly urges each local church to adopt its own screening procedure to ensure the safety and protection of its own children and youth, and requires a security background check for all chaperones and advisors of Presbytery sponsored events. The Presbytery relies on the local church session to fulfill its own responsibility to its children and youth.

2. All chaperones and advisors for the Presbytery of Scioto Valley activities involving children or youth are required to sign and follow a Covenant of Conduct Form. The Covenant of Conduct Form will include the safety and protection rules included in this policy and the recommendations for reporting. The Covenant of Conduct Form will also include a question about previous infractions regarding sexual misconduct.

Screening and Selection of Child Care Workers:

<u>1.</u>The Presbytery will not allow a Presbytery event involving childcare unless the host church has a child safety policy in place and meets the Presbytery set minimum guidelines below:

- a. Minimum of 2 adult (at least 18 years of age), background checked workers, CPR/First Aid Training is preferable.
- b. A sign in/out process which includes information about child allergies/special needs; includes a contact location/cell# for parent/guardian; includes a photo ID required pick up procedure.
- c. Diaper changing/bathroom procedure that follows "best practices"

When adopted, a resource packet including the above is located under "CNO" resources on the PSV webpage.

2. The screening, selection and supervision process of the child care workers will be handled by the host church, under the conditions of their child safety policy.

Safety and Protection Rules

1. At all times, leadership, chaperones, and advisors, to the best of their abilities, shall ensure the safety of the children and youth.

2. Leadership, chaperones, and advisors shall model positive and appropriate behavior.

3. Leadership, chaperones, and advisors shall behave respectfully toward others and the property of others.

4. At least two adults shall be present at activities involving children or youth.

5. As often as possible, make sure that an adult is not left alone in a space at these activities with a child or youth in a one on one situation. *If an adult needs to be alone with a child or youth, that contact should take place in public setting, and with the knowledge of the leadership or a leader (for example: at the far end of the dining hall, or one end of the basketball court away from activities).*

6. Leadership, chaperones, and advisors engage only in positive and appropriate forms of showing affection. The following examples are not intended to be all inclusive. Some examples of positive and appropriate forms of affection are listed below:

- Brief hugs.
- Pats on the shoulder or back.
- Handshakes.
- "High-fives" and hand slapping.
- Verbal praise.
- Sitting beside small children.

Some examples of inappropriate behavior with children and youth are:

- Any form of unwanted affection.
- Lengthy embraces.
- Kisses on the mouth.

• Touching bottoms, chests or genital areas other than for appropriate diapering or toileting of infants and toddlers.

Occupying a bed with a child or youth.

- Occupying a bed with a child of you
 Wrostling with shildren or youth
- Wrestling with children or youth.

• Comments or compliments (spoken, written, or electronic, social media) that relate to physique or body development.

• Giving personal gifts or money to individual children or youth.

7. One adult transporting one child or youth in a vehicle shall be prohibited. One adult driver may transport two or more children or youth, or two adults may transport one child or youth.

8. Leadership, chaperones, advisors, and children or youth shall remain at the site of an event for the duration of the event. No child or youth shall leave an event without permission. Permission will be granted only with the express written consent of a parent or guardian.

9. Current emergency contact phone numbers for parents/guardians shall be available to leadership, chaperones, and advisors.

11. Safety concerns may infrequently require staff and volunteers to employ physical measures. Leadership, chaperones, and advisors may only employ the minimum amount of physical measures required to ensure the safety of all those involved.

12. Corporal punishment (e.g., spanking, hitting, kicking) and verbal and/or emotional abuse are prohibited.

Enforcing and Following the Policy

All leaders and leadership of activities with children and youth shall be aware of this policy and sign an acknowledgement of this policy and that he or she agrees to follow and enforce this policy. The acknowledgement and agreement must be submitted to the designated Presbytery staff, on behalf of the appropriate commission, and kept on file. All chaperones and advisors in their Covenant of Conduct Form must acknowledge and agree to the safety and protection rules.

Reporting Safety Concerns

If a leader or leadership is aware of any safety or protection concern involving children or youth, he or she shall report such concern as soon as possible to any of the following: Presbytery of Scioto Valley staff, Moderator of the Presbytery, or any member of the appropriate commission. If a leader or leadership has knowledge of any incident in which the above safety rules have been violated, he or she shall report such incident to any of those identified above at the earliest possible opportunity. Forms for reporting such incidents shall be available to the person reporting, who shall use them to record pertinent information, including when accidents occur, or when physical measures are required. Allegations of incidents involving violation of these safety rules shall be addressed with respect to all parties involved, and timely notification of all parental, legal, social welfare, insurance or other authorities shall be made. Opportunities for spiritual and emotional support shall be offered. All reporting shall be dealt with discreetly and tactfully, and any allegations of misconduct shall remain confidential, except for legally required reporting.

Record Keeping

A. Presbytery Staff member designated shall be responsible for maintaining the following records.

1.Consents to perform a background check and background checks performed as to a volunteer or staff member. Background checks shall be performed every five years and their date shall be recorded. An electronic log confirming that the check was done and that no issue was found, as well as hard copies of past authorization forms shall be kept in perpetuity.

2. Any report received of a safety concern regarding a child or youth, materials collected in the investigation of such a report, and any document constituting or describing the resolution of the report, held by the stated clerk in accessible form for at least twenty-five years.

3. Any report made of a safety concern regarding a child or youth made to any governmental entity, held in perpetuity.

Policy Monitoring and Review

The Commission on Nurture and Outreach shall review these guidelines and recommend changes, as necessary, to the Presbytery. Our goal is to ensure that all I leaders adhere to these guidelines and to ensure that our children are well cared for.

Second Reading of the Healthy Boundaries Policy

HEALTHY BOUNDARIES POLICY

[Approved by Presbytery, MM/DD/YEAR] [Responsible Commission: Commission for Church Professionals]

I. <u>Introduction</u>

Psalm 119:10-16

¹⁰ I have sought you with all my heart.
Don't let me stray from any of your commandments!
¹¹ I keep your word close, in my heart,
so that I won't sin against you.
¹² You, LORD, are to be blessed!
Teach me your statutes.
¹³ I will declare out loud
all the rules you have spoken.
¹⁴ I rejoice in the content of your laws
as if I were rejoicing over great wealth.
¹⁵ I will think about your precepts
and examine all your paths.
¹⁶ I will delight in your statutes;
I will not forget what you have said.

For over three decades, the Presbyterian Church (USA) has acknowledged that sexual misconduct and exploitation have existed in its churches and among its members. Policies and procedures were put in place and have lessened the number of cases. We have learned a lot. The Healthy Boundaries training presents a positive approach to our professional conduct and responsibilities.

II. <u>Policy</u>

The Presbytery of Scioto Valley seeks to engage church professionals of the Presbytery in understanding, teaching, and maintaining healthy boundaries in their ministries.

This Policy will:

- Identify when training takes place and who should attend; and
- Define the process for annually reviewing and updating of this policy.

A Church Professional is defined as a Minister of Word and Sacrament, a Commissioned Pastor, or a Certified Christian Educator. The policy also applies to anyone who acts on behalf of the Presbytery such as staff, retreat leaders, mission teams, and Presbytery Commission members.

III. <u>Procedure for Healthy Boundary Training</u>

Compliance

- All Ministers of Word and Sacrament, Commissioned Pastors, or staff of Presbytery who are actively serving in a church or on the staff of Presbytery will be expected to receive certification every three years for having attended a Healthy Boundaries training course provided by the Presbytery of Scioto Valley.
- Other Ministers of Word and Sacrament and Commissioned Pastors who are not actively serving are encouraged to take this training to enhance their ministries to the church.
- Anyone working on behalf of the Presbytery of Scioto Valley will be expected to complete a Healthy Boundaries training course provided by the Presbytery of Scioto Valley.
- The Commission for Church Professionals will monitor compliance.
- The Stated Clerk will maintain the records of those who have completed the course.

All new church professionals will participate in the Healthy Boundaries 101 training course provided by the Presbytery of Scioto Valley within the first eighteen months of service. By the end of the fourth year of being received by the Presbytery, these church professionals will complete Healthy Boundaries 201. Every three years after this, they will complete a Healthy Boundaries Refresher Course.

Ministers of Word and Sacrament whose Healthy Boundaries certification is over two years out of date will not be considered for election to any presbytery commission or office, will not receive attestation for Personal Information Forms filed with the Church Leadership Connection, and will have their non-compliance noted in any reference check.

The commission of a Commissioned Pastor whose Healthy Boundaries certification is over two years out of date will not be renewed at the next commission anniversary. A new commission will not be approved until the Commissioned Pastor has obtained the required Healthy Boundaries training.

Courses Offered

The courses offered by the Presbytery will be:

- Healthy Boundaries 101 (a day long course) offered at least once a year.
- Healthy Boundaries 201 (a day long course) offered at least once a year.
- Healthy Boundaries Refresher Course (a two-hour course) offered at least once a year at PIE or in conjunction with Presbytery meetings.
- Healthy Boundaries Custom Workshop may be offered for specific groups prior to their service on behalf of the Presbytery (for example: prior to a mission trip or youth retreat)

IV. Updating the Healthy Boundaries Policy

This policy will be reviewed by the Commission for Church Professionals and the Stated Clerk. Any necessary changes will be presented to the Presbytery for approval. Additionally, this Commission shall annually review resources and make these available in training and on the PSV website.

Church Development Fund Policy

Presbytery of Scioto Valley

Adopted by Presbytery XX,XX, 2017

Introduction:

The Church Development Fund was established by the Commission for Presbytery Operations at its November 11, 2013 meeting. It encompasses four pre-existing funds; NCD Fund (D), Church Dev Fund (D), Cong. Fund Balance (R), and Building Fund (R). The former Board of Trustees had agreed in principle to do this late in 2012, but had not taken formal action. The fund creation was retroactive to January 1, 2013. The Church Development Fund oversight is responsibility of the Commission for Presbytery Operations.

Purpose: The purpose of the Church Development Fund shall be to advance church development in the Presbytery consistent with the mission of Christ within the bounds of the Presbytery in accordance with Scripture and the Constitution of the Presbyterian Church (U.S.A.), the mission and vision statement of the Presbytery, and the ongoing ministry strategy of the Presbytery and its Commissions.

Procedures:

The assets of Fund shall consist of:

- ✓ All real property, cash, and investments from the dissolution or separation of congregations and the sale of their real and personal property, as provided for in "Form of Government" (G-4.02) and the Presbytery Financial Policy (Article III.D).
- ✓ All cash and investments assigned to the Fund by action of the Presbytery or its Commission for Presbytery Operations.
- ✓ All dividends, interest and market gains on investments associated with the assets of the Fund.
- ✓ All proceeds from leases and notes issued to congregations.
- \checkmark All property received or purchased for new church development.

The Fund shall be responsible for:

- ✓ All liabilities, taxes, insurance, legal fees,
- ✓ Investment costs, and all market losses on investments,
- ✓ Any other expenses necessary to acquire, maintain, defend, transfer, or dispose of any of the assets of the Fund.

Assets of the fund may be allocated to projects and programs of the Presbytery by:

- ✓ Action of the Commission on Presbytery Operations to establish or continue a program or project consistent with the purpose of the fund,
- \checkmark Only if sufficient uncommitted balance of the fund remains.

The Commission for Presbytery Operations will report status of the fund to the Presbytery on a regular basis, no less than annually.

The Ministry Initiatives Program

A Program of the Presbytery of Scioto Valley administered by the Commission for Congregational Life

(Approved by CCL September 5, 2017)

Introduction: The Presbytery Church Development Fund was established in 2013. A Task Team was appointed to develop a policy for the use of these funds. Contingent on the approval of the policy for the Church Development Fund, this Ministry Initiative Fund is proposed to be supported from the Church Development Fund.

<u>Purpose</u>: The primary purpose of the Ministries Initiative Fund is to support development and initial implementation of imaginative efforts in the domain of church development and redevelopment in order to fulfill the Mission and Vision of the Presbytery of Scioto Valley.

Program Assumptions: As part of defining this purpose for the Ministry Initiatives Fund, the following assumptions are made:

- 1. Grants are generally intended for new initiatives, redevelopment of congregations or missions, or restart situations. Attainable and measurable benchmarks will be included in all proposals.
- 2. Funds are not ordinarily available for general maintenance and upkeep on buildings, or the operation of existing programs of the congregation. Exceptions may be considered if redevelopment includes maintenance needed to support uses described in item 1.
- 3. While administered by CCL, each Commission, and the Presbytery, may apply for funds for projects that meet the criteria. Each will receive equal consideration under these guidelines.
- 4. In instances where a congregation has petitioned CCL to engage in ending their ministry, funds may be available to assist with a closing celebration.
- 5. Cooperative efforts among the congregations of the Presbytery will be encouraged, with grants in cases where these congregations may meet the criteria in assumption item 1.
- 6. CCL will establish a panel to oversee grant requests, herein named the Ministry Initiatives Board (MIB). The MIB will consist of one (1) active member from each commission, the active Vice Moderator of the Presbytery, and one (1) presbytery staff persons. The Vice Moderator will serve as the MIB moderator and the staff person will serve in an advisory and non-voting capacity.
- 7. The MIB will set the timing, criteria, and process for receiving and evaluating grants. The MIB will be asked to make final determination for funding requests. Approved grants will be submitted to CCL for payment using the appropriate presbytery forms.
- 8. While requests may come from individual congregations to the various commissions, it will be the responsibility of each commission to determine eligibility, evaluate, and present recommended applications to the Ministry Initiatives Board. *Requests to the Ministry Initiatives Board must come through, and be supported by, one of the commissions or the Presbytery.*

- 9. All granted requests will be accompanied by anticipated outcomes and the requesting commission will report those outcomes to CCL.
- 10. Grants may be considered for additional program years, up to two (2), in instances when anticipated outcomes may require more long-term planning and support. However, the requesting and supporting commission must provide all required outcome reporting to CCL. Additional years, beyond two (2), may be available, but will require a new grant request and consideration by the Ministry Initiatives Board.

Funding Assumptions:

- Initially, and for a projected period of five (5) years, an annual amount of \$150,000.00 will be included in the budget of CCL and named the Ministry Initiatives Fund. Even though \$150,000.00 is allocated per year, there is no assumption that the entire annual amount will be spent in any given year if the presented and approved applications don't warrant the expenditure. The unexpended balance would be returned to the Church Development Fund for future use.
- This funding program will be evaluated by CPO and CCL in a period of no more four (4) years. Initial funding assumptions by CPO determined that funds are available for five (5) years at this funding level. Program assumptions may be evaluated for appropriateness by CCL as needed, or at least annually.
- If, at any time, CPO determines an adjustment is necessary to preserve the stability of the funding source(s), new allocations may be reduced or suspended.
- Should there be an unexpected opportunity consistent with the purpose of the fund, the Presbytery, through a request to CPO, may approve spending more than the \$150,000 yearly limit.
