1 pm PSV Nominating Committee Zoom Meeting As the state has begun relaxing the pandemic restrictions, businesses and organizations have begun the process of reopening. Churches are doing the same, including my church, Westerville-First. Like every church we sought guidance from the state, from the Center for Disease Control and Prevention (CDC), from the Presbytery of Scioto Valley (PSV), from other churches, from anywhere we could find it. Most of the guidance was informative. Much of the guidance was repeated over and over. Some of guidance was contradicted by other guidance. All of the guidance was helpful. However, what we discovered was that while all the statements from the CDC and the State of Ohio and PSV and every other source was necessary, it was not sufficient. For what we learned was that while such guidance informed our decisions, it was the process of wrestling with those decisions that was most important. As we discussed when and how we should reopen our church, the enormity of the task became apparent. As we began to picture worship in our setting under social distancing rules, we began to see that things would not be anything like what we were imagining. When we realized that there were many in our congregation who could not and would not join in any group gatherings any time soon, we were forced to ask ourselves how do we minister to them and with them in the weeks and months to come. As we considered those questions, we realized that we were also considering larger questions of who we are as a church and to what ministries is God calling us. The words from Revelation came to mind, "And the one who was seated on the throne said, 'See, I am making all things new." Sometimes when we wrestle with the problems we face, God reveals something new, and we discover new opportunities to share the good news. We are learning this truth, right now!

The four Special Offerings of the PC(USA) are each connected to a season of the church year. These Offerings engage congregations in ministries of compassion, justice, Christian formation, education, peacemaking, and global witness. The Pentecost Offering is normally promoted and received on Pentecost Sunday in May.

The Offering is divided into the following categories: 40% supports youth in your own church; 25% serves young adult volunteers; 25% supports ministries with youth; 10% provides advocacy that protects and nurtures children and youth.
