News From the PC(USA) Board Of Pensions (BOP)

Each year the BOP sets a time for selecting benefits for the coming year. The Employer Agreements are now available on Benefits Connect at pensions.org/2021benefits. The Board of Pensions has designed the Benefits Plan of the Presbyterian Church (U.S.A.) so employers have the flexibility to choose from a variety of benefits options that best meet the needs of the organization and the employees. Once your church has signed their Employer Agreements, Open enrollment for benefits will run from October 26 to November 13.

There are changes and new benefits that make it possible for churches to enroll their pastors who are not installed. The new *Minister's Choice* package, available in 2021, offers savings for non-installed ministers working at least 20 hours per week. Minister's Choice is a new benefits package that provides important financial protection for ministers. Coverage under the Minister's Choice Plan includes the Defined Benefit Pension Plan, Death and Disability Plan, Temporary Disability Plan, and Employee Assistance Plan. Minister's Choice also expands access to assistance and education programs now available only through Pastor's Participation. Employer cost for Minister's is 10 percent of effective salary. PSV Commission for Congregational Life (CCL) Technology GRANTS...

The CCL Technology grants will be available through August. As our congregations were thrust into the world of virtual worship with the inception of COVID-19, many of us were completely unprepared for the task of Zooming or streaming worship. It's probably something you had talked about doing, someday, and suddenly someday appeared without warning. And now you are doing it trying to piece things together to keep up the progress. You might need some electronic stuff to make this all work moving ahead. If you are a congregation who needed to purchase technology equipment to keep up with streaming to friends in many places, CCL is ready to help with the purchase of technology equipment. The Technology Support Grant, offered by the Presbytery Commission for Congregational Life (CCL), has allocated funding for up to \$500 reimbursement grants to any church in the Presbytery for purchased materials that assist pastors and congregations in reaching out to members through technology during the COVID-19 Crisis. Items can be purchased anytime between March 8 and August 31, 2020. Time is running out, so get your requests in soon. Scholarship applications will be reviewed beginning 8/31/20 and New Covenant and Racial Ethnic Grants beginning 10/1/20. (Note: These are not deadlines; they are beginning points.)

If you dig into the applications for the Racial Ethnic or New Covenant grants, you'll see that we have added a letter of endorsement from the EP, GP, or Stated Clerk (if there is no EP or GP). Guidance to Congregations Considering Re-Opening

As congregations consider returning to in-person worship or re-opening their buildings, Sessions must be mindful of both their legal and fiduciary duty to take reasonable steps to minimize the risk of spreading Covid-19 infections by worship or other church activities and their ordination vows to "watching over the people, providing for their worship, nurture, and service" (W-4.0404b) and "give[s] full expression to the rich diversity of the church's membership" (G-3.0103). This includes assessing whether a plan promotes expanding those who can worship or has the effect of excluding individuals whose risk factors prevent participation in in-person worship. In carrying out these obligations, we strongly urge Sessions to consider the following guidance for congregational safety:
