KENTUCKY COUNCIL OF CHURCHES 70TH ANNUAL ASSEMBLY OCTOBER 19 - 20, 2017 DELEGATE'S REPORT—Mike Ward

The 70th Annual Assembly of the Kentucky Council of Churches was held on October 19 - 20, 2017, at the Jeffersontown Christian Church in Louisville, Kentucky. Delegates from the KCC member judicatories (including Transylvania Presbytery) as well as other guests and visitors attended the gathering, one hundred or so persons in total.

The theme of this year's Assembly was "Unpacking Power and Privilege." The program included keynote presentations from Mr. Jack Jezreel (JustFaith Ministries, Louisville) and Dr. Miguel De La Torre (Iliff School of Theology, Denver). The Rev. Traci Blackmon (United Church of Christ) preached at the Assembly worship service. Workshops at the Assembly included "Making Space for the Conversation: Working to Remove Systemic Racism," "No Shelter in the Storm: Basic Human Needs, Immigration Privilege and the Undocumented Jesus," "Environmental Justice in Focus: Exploring Impacts at Home and Abroad," "The Impact of Disparities on Health," and "A House Divided" (introducing the 2018 Assembly theme).

At the Assembly Banquet, awards were presented to several organizations for significant work in the area of "living justly" (the 2016 Assembly theme) including the Kentucky Coalition to Abolish the Death Penalty, New Roots: fresh food is a basic human right, and NIA Urban Ministries.

The final plenary session of the Assembly included a simulation exercise, "The Racial Wealth Gap Simulation," guided by Ms. Marlysa Gamblin of Bread for the World. The simulation allows participants to learn why communities of color are twice as likely as the general population to experience hunger and poverty. The simulation outlines 13 federal policies and their use of racial discrimination in creating the wealth, income and hunger gaps we see today.

KCC Executive Board officers for 2018 were elected during the business meeting, including the Rev. Philip Lotspeich who will continue his service as Secretary of the Executive Board.

As a delegate representing Transylvania Presbytery, I found the Assembly to be informative and challenging and inspiring, both in its formal program and in informal conversations with sisters and brothers from around the Commonwealth. I would encourage anyone to attend future Assemblies, whether or not serving as a judicatory delegate. Thank you for the opportunity to represent Transylvania Presbytery in this way.

I learned that the council is all about the coming together of a diverse people to the common ground of the **Cross** in a united voice for the common good, to fight against injustice, to free the oppressed, and feed the hungry; on the theme of deconstructing power and privilege.

The Rev. Dr. Meguel De La Torre gave an impassioned speech on how to liberate the oppressed by deconstructing the white privileged world view. He said the word "hope" in Spanish means "to wait for" and often for people of color, the end of waiting is not good. All too often the white, privileged world view of history has whitewashed the dark world of the oppressed and enslaved. The chaos of history does not offer much hope as the oppressed cannot get past the pain and death of Saturday to get to Sunday's resurrection.

Rev. De La Torre asked us if we struggle for justice because we think we can win, or because we have no choice? He said "the struggle defines my faith; it is who I am." The Puritans brought with them a whitewashed view of the Bible which persists to this day. Many people of color have always seen the real Jesus/Satan as "tricksters", an ethic of deceit in order to spark change for the good/bad. The virtue ethics of the privileged has brushed aside the survival ethics of the oppressed.

His challenge to the group: Embrace hopelessness as not despair, the state of the world today, but in the sense that because the hopeless have nothing to lose, change for the better is possible.

I attended an eye opening workshop by Dr. Emily Askew on the topic of "Immigration Privilege". She got us engaged by asking each of us to tell the group where their mother's grandmother came from; that our story, not our station in life, is what is important. She asked what does it mean to be a "sanctuary congregation"? What do we as documented citizens take for granted? The undocumented fear that when they see their children off to school that they may not see them again; that ICE may arrest them if they seek shelter after a hurricane; that the abused won't go to court for fear of arrest by ICE. People of color are viewed negatively for more often than white or Asian. Only 3% of undocumented are criminals. Most are guilty of the "crime" of crossing the border, having a fake SS card so they could work, or driving without a license.

Her challenge: reciting facts and figures won't change people; stories will.

The second workshop I attended was "A House Divided" which gave a glimpse on next year's theme. Two "RUXers", members of the Kentucky Urban Rural Exchange, explained how they try to bridge divides by the "art of the rural", a process called "creative place making", helping people have meaningful experiences so that they can grow in understanding and love. This involves listening to other's experiences, respecting their space, and reflecting on what action to take in love; listening to understand and be able to unpack the power and privilege that may have been a stumbling block.

Participants were asked: what issues are dividing your community? What resources does your community have? What are needed? What do you want your community to look like in two generations?

The sermon by Rev. Traci Blackmon during Thursday's assembly worship, called "We Are Living In A Breach", was a powerful call to action. Based on Isaiah 59, she called the listeners to "embrace the theology of resistance; to reject the theology of favoritism (chosen ness)". We are called to repair divisions with the tools God has already provided; to empower the needy and oppressed. She said we need to "put skin in the game".

Kentucky Council of Churches Annual Assembly 2017

Delegate Report

The focus of the 2017 Kentucky Council of Churches Annual Assembly – **privilege** – is not a new issue, nor is it new to me. As a sociologist I regularly teach about the ways that privilege in race, gender, socioeconomic status and such plays out in our lives, and I often use my own socio-economic background and my race as examples of my own privilege in the classroom. That said, I was not certain how much "new" I would get from the speakers and events at the assembly. I quickly learned just how much God had in store for me as the speakers began, and have returned home challenged to disrupt much of the comfort my privilege has provided.

Mr. Jack Jezreel of JustFaith Ministries drew on the work and words of Pope Francis to call us to heal the ruptures in our society by encounter that goes and creates kinship, not a distant charity. A workshop led by Rev. Dr. Charisse Gillett, President of Lexington Theological Seminary, invoked the words of bell hooks to call us to not fall prey to the current ahistorical mood, but rather to take stock of where we are and where we have been and where, particularly as it relates to systematic entrenched privilege, we have yet to go. Using the words of Isaiah, Rev. Traci Blackmon called us to become repairers of the breach in which we currently live (in either our privileged or less privileged positions) by "putting skin in the game" and engaging in behaviors that strive for reparations. Finally, on Friday morning, Rev. Dr. Miguel De La Torre of the Iliff School of Theology called us to reside with the people who live in hopelessness, who live in despair, in what he called "Holy Saturday." Too often, our Eurocentric frameworks rely on a narrative of order and purpose that allows those of us in comfort to call those in despair to have hope and trust in the order of things. We opt to live in Holy Sunday, having skipped the Holy Saturday that entrenches the lives of others. Rather, we need to practice a faith that lives in ambiguity, that looks for the actions for now, that is now the hands and feet of Jesus walking in the breach we seek together to repair.

I am yet grappling with the (new to me) awareness that it is privilege that allows me to think about my privilege only when I CHOOSE to do so. It is privilege that I can walk away from the breach when I feel I cannot go on. From the Assembly and the words of those gathered, I know I must listen to the call to go. To go not to lead, but to listen, to go to ask, to go to be vulnerable, and to go to repair the breach together.

Report on Kentucky Council of Churches Assembly Susan Warren October 30, 2017

Profound challenges to privilege – in many cases, privileged white churches – emerged from keynote speakers, group leaders and worship at the 70^{th} annual assembly of the Kentucky Council of Churches meeting in October in Jeffersontown.

"We have domesticated resistence and protest," said the Rev. Dr. Miguel De La Torre, who along with others urged a radical approach to rejecting privilege and focusing on mission. Torre and others speakers stressed the importance of reconciliation with victims of racial, social and economic injustice – something that can be accomplished only by listening and working together closely.

This year's theme, "Unpacking Power and Privilege," brought together clergy and lay members of churches that focus on ecumenical relations. Also at this year's assembly, the Rev. Dr. Donald Gillett II was formally installed as new executive director and plans were announced to hire a lobbyist to discuss council views with Kentucky legislators. Among a number of other issues council has taken positions on behalf of juvenile detainees, opposing the death penalty, and implementing gun control measures.

Topic: "The Pastoral Dimensions of Addiction" Speaker: Dr. G. Wade Rowatt, Senior Professor of Pastoral Care and Counseling, The Baptist Seminary of Kentucky.

Dr. Rowatt has served as the Director of the St. Matthews Pastoral Counseling Center in Louisville, Ky from 1995 to 2009 and professor at Southern Baptist Seminary, University of Louisville, McMaster Divinity College (Hamilton, Ontario) and the Baptist Seminary of Kentucky. A Diplomate in the American Association of Pastoral Counselors (AAPC), a Supervisor in the Association For Clinical Pastoral Education (CPE), and a Clinical Member of the American Association of Marriage and Family Counselors (AAMFT), Dr Rowatt has authored or co-authored several books, dozens of articles and led numerous retreats. All clergy are invited to attend this retreat to spend time with colleagues, take a deep breath before the Lenten Season, pray and consider together this important issue in all of our communities.

RECOMMENDATIONS:

Elders:

1) That the Proposed Changes to Minimum Terms of Call for 2018 be approved (attached).

For information: The Commission created a Minimum Terms of Call Task Group in January 2017 to study and recommend revisions to the Minimum Terms of Call to be considered by the presbytery at its November, 2017 meeting for implementation in 2018. The Task Group members, Darryl Baker (TE/Honorably Retired), E. G. Clark (TE/small church pastor), Candace Purdom (RE/small church), Bill Reed (CRE), were asked to consider the changing and diverse ministry models and economic realities across the presbytery, the theology of compensation, and fairness for churches and pastors in differing economic regions/situations. The Task Group recommendations were approved by the Commission and the proposed changes to the presbytery at the August 12, 2017 presbytery for study and comment. The recommended Minimum Terms of Call contain the following changes from the 2017 Minimum Terms of Call:

- a. Change basic full-time minimum salary figures for 2018 from \$28,000 to \$29,000 with manse & \$40,000 to \$41,000 without manse.
- b. Add paragraph about salary change being comparable to beginning master degreed public school teacher.
- c. New paragraph about 20-40 hours per week covenant/contract relationships including minimum full participation for health coverage at \$10,800. The previous language suggested pastor paying some of that cost.
- d. New paragraph dealing with pastors/CRE's working under 20 hours per week at \$25 an hour plus travel with small amount for continuing education.
- 2) That Transylvania Presbytery grant an exemption for the required ordination examinations for Hyeon Gu Lee, under G-2.0505 a. (2) (which provides that such an exemption may be granted a minister of another Reformed church who has been ordained for five or more years by a two-thirds vote of the presbytery), and receive Hyeon Gu Lee into membership from the Youngdeungpo Presbytery of the Presbyterian Church of Korea.

For information: The Rev. Hyeon Gu Lee has been serving Lexington Korean Presbyterian Church as Temporary Stated Supply since 2015 when he was granted temporary membership in Transylvania Presbytery. He desires to become a part of the Presbyterian Church (U.S.A.) and has requested that his membership be transferred to Transylvania Presbytery in order that he may take a more active part in its mission and ministry. In meeting with Hyeon Gu and the leaders of Lexington Korean Congregation, the Pastoral Transitions Commission has seen much evidence of his effective ministry and is satisfied that he possesses the qualifications necessary to provide solid pastoral leadership to this mostly Korean-speaking congregation. Hyeon Gu is fluent in Korean and English. He has presented excellent transcripts from the Presbyterian Theological Seminary in Korea where he earned his M.Div., from Pittsburgh Theological Seminary where he earned a MA. in education and STM in mission, and from Asbury Theological Seminary where he is pursuing a PhD. He was ordained in 2005 by the Youngdeungpo Presbytery, which has certified that he is a member in good standing. He has served congregations in both Korea and the United States. Under Hyeon Gu's leadership, the Lexington Korean congregation has grown in vitality, numbers, financial stability, and outreach to the community, and congregational leadership is being developed and strengthened.

The *Book of Order* (G-2.0505) offers guidance on the transfer of ministers of other denominations, particularly in the case of those called to serve immigrant congregations. The Pastoral Transitions Commission believes that receiving Hyeon Gu Lee will further the presbytery's mission with Lexington Korean Presbyterian Church and is satisfied that he has met all other requirements necessary to be received as a member of Transylvania Presbytery.

Presbytery of Transylvania Minimum Salary Requirements for Pastoral Positions in the Presbytery Recommended to Presbytery November 11, 2017 for the Year 2018

These requirements are intended to provide congregations with assistance and guidance in both calling new pastors and in the annual review of the terms of call. The categories used in these terms are in use generally throughout the Presbyterian Church (USA). They are intended to provide a uniform set of items to be considered by ministers and congregations in their discussions and negotiations. They are also intended to assist Presbytery in taking seriously its responsibility to support and nourish pastors and congregations.

Effective January 1, 2017 the Board of Pensions has elected to restore call neutrality. Pastor only medical coverage and the optional family medical coverage have been eliminated. For 2018 the Board of Pensions will offer one medical coverage rate billed at 25% of effective salary. This provides full medical coverage for spouses and all family members. The minimum basis for effective salary for medical coverage remains at \$44,000 for 2018.

In the opinion of the Pastoral Transitions Commission (PTC), the minimum salary for a pastor should be comparable to the starting salary of a new master's level public school teacher. While we believe that the salary listed above is consistent with those teacher salaries, it is true that they vary from county to county. Should a church find that the new public school teacher salary is lower in their county, said church may petition the PTC for a lower minimum salary. Appropriate documentation should accompany such a request. The PTC will give such a request serious consideration.

Provisions relating to pastors whose contracts provide for between than 20 hours per week and 40 hours per week.

For those pastors who enter into a contract to work an amount of time that is between full time and half time, there should be an attempt to estimate the number of hours that will be required to perform the duties specified in the contract. The minimum to be paid should be equal to the percentage of 40 hours that the contract requires. For example someone working 30 hours per week should be paid at least (3/4) 75% of the full time minimum. However be advised that BOP benefits are required and the BOP currently requires a minimum amount of \$10,800 per year for full medical coverage (25% of \$44,000) and 12% of the salary for pension, death and disability benefits. Also note that the standard levels of vacation (4 weeks) and study leave (2 weeks) apply. In the case of a 30 hour per week contract one week of vacation or study leave is one 30 hour week. Travel should be reimbursed at the prevailing IRS rate.

Provisions relating to pastors whose contracts provide for less than 20 hours per week.

Many smaller churches will want to secure pastoral leadership on a very part time basis. It is also possible that larger churches would need part time pastoral services to augment their other staff. When the time commitment for such a position is less than 20 hours per week, no pension or medical dues are required. Pension contributions would be available on a minimum participation basis. Such a person would not be eligible for medical coverage.

There will, of course, be a wide variety of tasks that a church might ask a part time person to perform. The required tasks and time commitment should be negotiated between the church and the teaching or ruling elder, then put in writing. Compensation to be at least \$25 per hour plus mileage at the prevailing IRS rate plus a modest sum for continuing education.

It is hoped that these "slightly less than 20 per week" jobs are just that and not 2/3 or 3/4 time jobs masquerading at less than half time in order to avoid Board of Pension dues. It is possible that in certain situations a church might owe vacancy dues to the BOP.

Presbytery of Transylvania Terms of Call Requirement for Pastoral Positions in the Presbytery

- 1. The minimum for cash salary, housing equity, and continuing education be proposed by the Commission on Pastoral Transitions and set by Presbytery each year at the last meeting before the next calendar year.
- 2. Ministers who live in church-provided manses receive a utilities/housing allowance to the extent necessary to cover these expenses, thus allowing them to take advantage of current IRS rulings.
- 3. Churches with a manse for their ministers pay at least the minimum set by Presbytery into a housing equity account to accrue for the benefit of the minister at the time of the termination of the call. These monies should be deposited in a 403-b Retirement Savings Plan (i.e. the Board of Pensions 403-b).
- 4. Churches without a manse provide a housing allowance sufficient to cover rent or mortgage payments, insurance, taxes, utilities, furnishings, and maintenance.
- 5. Churches reimburse their ministers for one-half of their IRS Schedule SE self-employed social security with this amount to be paid monthly, quarterly, or annually, as the minister and church decide.
- 6. Churches pay the entire pension and medical payment for their pastors (the pastor and eligible family members are covered under the medical plan).
- 7. Churches reimburse pastors for the actual expense incurred in their professional work, including mileage, food and lodging and books and magazines.
- 8. Churches pay at least the minimum set by Presbytery for continuing education. This amount may accumulate over a period of three years. The content of this continuing education will be negotiated with the session. (SEE the policy on Continuing Education.)
- 9. Ministers receive 4 weeks of paid vacation annually.
- 10. Ministers receive 2 weeks of continuing education leave annually. This time may accumulate up to six weeks over a three-year period.
- 11. The Presbytery sick leave, parental leave and continuing education policies be adopted by congregations as part of the terms of call. (SEE over the policies on Continuing Education, Parental Leave and Sick Leave.)
- 12. The PNC, session and congregation should be strongly encouraged to offer sabbaticals to pastors and certified educators after 6 years of continuous service to the congregation.

Continuing Education Requirements for Ministers in Transylvania Presbytery

The purpose of providing ministers with time and money for continuing education is to allow them to improve their effectiveness as ministers. Study leave gives them the resources to study particular topics in depth, learn new skills, and grow as ministers.

Churches in Transylvania Presbytery shall provide their ministers with funds for continuing education and a minimum of two weeks annual study leave. Upon negotiation with the Session, continuing education time and money can accumulate for up to three years to provide for an extended study period.

Both the topic and the schedule for continuing education should be negotiated with and approved by the Session. The minister should report back to the Session about the continuing education experience upon its completion.

Sick Leave Policy for Transylvania Presbytery

Sick Leave/Personal Leave

The purpose of this leave is to allow the church staff members (ordained and lay) to take time off with pay for sickness and other needs. Such need might include childbirth, illness, injury, or death in one's immediate family, and jury duty or other responsibilities. Sick leave/personal leave shall normally be calculated at one (1) day per month of service or employment. This leave may accumulate up to sixty (60) days.

Extended Sick Leave/Personal Leave

In cases where more extended leave of absence is indicated, negotiations shall be made between the staff member (or his/her surrogate in case of incapacity) and the Session, with the advice and approval of the Pastoral Transitions Commission, to determine appropriate and humane terms of leave extension. Such extended leave may be with or without pay, as negotiated and approved. It includes, but is not limited to maternity/paternity leave, major illnesses, surgeries, accidental injuries, or critical family situation.

Involuntary Dissolution Policy

Although the *Book of Order* clearly outlines the basic process for the dissolution of pastoral relationships (G-14.0600), it does not fully address the implications of a situation in which the pastor does not concur with that action (G-14.0603), a situation commonly described as an "involuntary dissolution."

The dissolution of a pastoral relationship is quite often a time of great turmoil and distress for both the congregation and the departing pastor, and this is especially true in the case of an involuntary dissolution.

It is the responsibility of all parties involved (the pastor, the congregation, and the presbytery's Commissions on Pastoral Transitions and Congregational Issues) to work together in the case of an involuntary dissolution to address the sometimes conflicting needs and competing concerns of the congregation and the departing pastor.

Pastors do not receive unemployment benefits from the state, and our denomination cannot guarantee that a departing pastor will receive a new call within any specified period of time. Therefore, in the case of an involuntary dissolution, fair and adequate terms of severance are necessary to protect the departing pastor during the search for a new call.

While such provisions may present a degree of financial hardship for the congregation, the lack of such provisions would almost certainly present an even greater degree of financial hardship for the departing pastor and his or her family.

In order to address the concerns outlined above, the Commission on Ministry recommends that, effective January 1, 2006, the following provisions be added to Transylvania Presbytery's standard form for terms of call (See *Book of Order* G-14.0507e).

In the event of an involuntary dissolution of your pastoral relationship with this congregation, for any cause other than criminal activity, sexual misconduct, financial malfeasance, or a finding of guilt in a disciplinary case resulting in either temporary exclusion from the exercise of ordained office or removal from ordained office, you shall be afforded as severance benefits a continuation of your then current salary and benefits being provided for a negotiated period of time which shall take into account your tenure...among us—but not less than three months. Such compensation will cease when full-time employment is secured. Such payments shall be made monthly, not as a lump sum settlement. During the severance period, it shall remain the congregation's responsibility to continue all benefit payments to the Board of Pensions

In the case of criminal activity, sexual misconduct, financial malfeasance, or a finding of guilt in a disciplinary case resulting in either temporary exclusion from the exercise of ordained office or removal from ordained office, in an effort to be redemptive and in consideration of your family and with respect for your past ministry to this congregation, you shall be afforded as severance benefits a continuation of your then current salary and benefits being provided for a period of one month.

PARENTAL LEAVE POLICY Presbytery of Transylvania

Theological Grounding

God created us to be in relationship with one another, to care for one another, and to participate in families. We are required to honor our father and mother, and to care for our children. As congregational leaders, we are to encourage healthy families and healthy priorities. Parental leave gives the mother or father a chance to establish a healthy connection with her or his child and model good family life for the congregation.

As part of the minimum compensation requirements of the Presbytery of Transylvania, every call to a Presbyterian minister, a Commissioned Ruling Elder, or a Certified Christian Educator in the Presbytery of Transylvania shall provide for the following Parental Leave provisions for childbirth and/or adoption as a minimum.

- 1. Maternity leave: Two (2) months of maternity leave with full pay and benefits, excluding travel expenses or allowances, shall be included in the terms of each call.
- 2. Paternity leave: Three (3) weeks of paternity leave with full pay and benefits, excluding travel expenses or allowances, shall be included in the terms of each call.
- 3. A Minister, Commissioned Ruling Elder, or Certified Christian Educator, desiring parental leave, must submit a written request to her Session, ordinarily thirty (30) days prior to the start of the leave.
- 4. Parental leave ordinarily begins at the time of delivery or when appropriate in the adoption procedure. Complications related to a pregnancy will be considered medical leave.
- 5. In the event of a miscarriage or stillbirth, the pastor shall be granted the same parental leave she/he would have received had the pregnancy been carried to term with no complications.
- 6. The pastor should be relieved of all pastoral responsibilities for the duration of the parental leave. The Session is responsible for the ongoing work of the congregation during this time. Session should be ready to arrange and pay for pulpit supply, a Session moderator, coverage for hospital and emergency visitation and continuation of teaching and programming for which the pastor was responsible.

Vacation time may be added to Maternity or Paternity Leave Time with full pay and benefits. Requests for additional Maternity or Paternity Leave Time due to the individual circumstances of each birth or adoption may be negotiated with the Session and with the assistance of the Pastoral Transition Commission.

We meet to ready ourselves, and future teammates, and to be assets to the revitalization or the creation of new worshiping communities. We seek the Holy Spirit for direction, wisdom and confirmation and are keenly aware our experiences, passions and endeavors are for naught without God's guidance.

The CRD team is ardent about being "a", and not "the" resource for the presbytery.

• The following is a synopsis of who we are and what we are striving to undertake:

. The Why of Our Existence

As Presbyterians, we believe the church is reformed and always reforming according to the Word of God, who is Jesus Christ. That means the why, following Jesus, of our ministries is permanent. But, the how, exactly what we do to serve, are not permanent fixtures but nimble service projects that we continually subject to the leading of the Spirit. 

Presbytery of Transylvania Narrative Budget Presented by Administrative Commission

Over the past couple of years, the Presbytery of Transylvania has been undergoing change. We have been focused on taking what we have done very well and building on that success to better serve our churches in their quest to fulfill God's mission in their specific community. We have:

- Focused our energy on helping churches in transition find great pastoral leadership.
- Created a new Leadership Development Ministry to complement our Christian formation work
- Continued to work on a sustainability plan for Camp Burnamwood,
- Created a commission to assist congregations with the various issues they face.
- Given many mission grants to congregations in support of their local mission.
- Supported numerous candidates and inquirers through the process of seeking a call as Ministry of Word and Sacrament
- Participated faithfully in our Synod's Living Waters for the World mission
- · Supported and funded Mission on a national and global level
- Supported the work of Presbyterian Disaster Assistance

And much, much more.

The Presbytery is excited about the new things that God is doing in this time of great change. It is the purpose of our Narrative Budget to give everyone an idea of how the Presbytery spends \$466,000 toward supporting our 79 congregations in Central and Eastern Kentucky. It's a big amount of money, but we all consider it an investment in doing God's good work in partnership with one another "Across the Woods". We encourage you to reflect on the amount devoted to each ministry in relation to the many programs and activities offered for the benefit of everyone in the presbytery. And, of course, we trust you will pray about your financial support of the Presbytery and what an important difference your regular, meaningful contributions make to the present and future potential of our church family.

Recommendations to Presbytery

The **unbalanced budget** is being presented to the Presbytery with the following recommendations:

- 1. The Presbytery's portion of total per capita per member be set at \$25.51 per member for 2018. The total per capita per member is \$36.86.
- 2. The distribution of Unified Mission Giving for 2018 be as follows:

Transylvania Presbytery	78%	(same as 2017)
General Assembly	17%	(same as 2017)
Synod of Living Waters	5%	(same as 2017)

3. That the 2018 Operating Budget of \$466,000 and the Burnamwood Subsidiary Budget of \$252,000 be adopted.


Per capita is an opportunity for all communicant members of the Presbyterian Church through the governing bodies to participate equally, responsibly, and independently by sharing the cost of coordination and evaluation of mission; of performing ecclesiastical, legislative, and judicial functions that identify a Reformed church, while at the same time strengthening the sense of community among all Presbyterians. The payment of the per capita apportionment can be seen as a sign of healthy relationships within the church, giving tangible witness to the unity and wholeness promised to us in Jesus Christ. The per capita assessment was instituted and still exists to help cover the fixed costs of operating our Church. The assessment is not used to fund mission programs, either on a national or presbytery level; rather, it exists solely to assist in the payment of the basic necessities of our institutional existence.

The recommended 2018 per capita is \$36.86 per member. Of this amount, \$7.73 per member is forwarded to our national church offices, \$3.62 per member is forwarded to our Synod, and \$25.51 per member stays in Transylvania Presbytery.

Unified Mission Contributions \$226,567

Why give to Unified Mission? Because we believe in the Presbyterian Church (USA) "brand" of the Christian household of faith, and wish to express our discipleship through the giving channels provided by the Presbytery, Synod and General Assembly.

Our unified mission dollars support missionary salaries and benefits, gifts or grants to ecumenical agencies, overseas partners [churches, hospitals, schools]. resources and services to congregations and mission governing bodies.

As you know, Paul worked tirelessly preaching, teaching, evangelizing, and raising funds for the saints working in churches throughout the known world. Since then churches have always pledged a portion of their resources for mission beyond the local congregation, thus helping fulfill the Great Commission.

So what happens to the unified mission giving sent to the Presbytery?

- 78% is kept in the Presbytery
- 17% is sent to General Assembly
- 5% is sent to the Synod

These percentages are set by action of Presbytery each year at the last presbytery meeting of the year.

Interest from Investments and Designated Accounts/Reserves \$89,417

This budgeted revenue includes interest and dividends on designated funds, which support Presbytery operations, designated funds to support ministers in need, designated funds to support church redevelopment grants and the Calvin Event. Included in this amount are reserves from the sale of the 412 Rose Street Property.

Uses of Funds

Our congregations count on the Presbytery to support pastors, sessions, and congregations in times of pastoral transition and conflict; to provide oversight to inquirers and candidates coming from our churches, to administer funds received and given through the presbytery, to communicate regularly and effectively using electronic, print and social media. The Presbytery has committed itself to providing leadership and guidance to the congregations in carrying out its mission and adopted the following strategies of the Long Range Plan in January of 2015.

- Form and nurture "neighborhoods" of congregations based on shared passion and missional affinity.
- Encourage the strengthening of small congregations
- · Restructure Presbytery meetings for increasing effectiveness
- Establish Technology Stations throughout the Presbytery to enable relationships and broaden participation.
- Support Camp Burnamwood's Mission
- Continuously communicate the Presbytery's mission and successes with its members.
- Reshape staff roles and responsibilities to align with recommendations and strategies

Provides for general management of the business affairs of the Presbytery, serves as a staff resource and financial consultant to the treasurer, staff and committees of the presbytery; serves as administrator of office functions, bookkeeping, accounting, computer operations, acts as property administrator; serves as liaison to the Board of Pensions.

Operations Expense \$45,000

This portion of our per capita budget supports the work of our staff and committees in administering the administrative and clerical work of the presbytery including printing, postage, telephone, office supplies, computer support and equipment, presbytery website, online directory, insurance, and storage.

Commissions and Ministries of the Presbytery \$162,500

Administrative Commission \$1,300

The Administrative Commission serves as the Trustees of the Presbytery, and has the responsibility for accounting, budgeting and staff services for the presbytery. The Commission reviews and monitors the financials of the presbytery on a monthly basis, develops the presbytery budget and provides annual reviews for the staff.

Camp Burnamwood \$70,000

The Burnamwood budget is a subsidiary budget of the Presbytery's operating budget. Unified mission dollars from the presbytery's operating budget is used to supplement the operation of Camp Burnamwood. By providing a positive and energetic 500-acre environment in Central Appalachia, we are dedicated to aid in the spiritual



development of children, youth, and adults. Burnamwood hosts a full summer of life-changing activities through summer camps and the Burnamwood Appalachian Ministry. During the non-summer months, Burnamwood offers the same



experiences, through weekend retreats and rentals. Staff support is provided by Executive Camp Director, Robby Lear. robby@burnamwood.net

Christian Formation Ministry \$13,000

The Christian Formation Ministry coordinates the Presbytery's work in strengthening and supporting congregations in their faithful discipleship through Biblical and theological knowledge, and a commitment to stewardship, and spiritual formation. Throughout the year, the Christian Formation Ministry provides for educational opportunities in the presbytery such as the Calvin Event, workshops at presbytery meetings, Youth Triennium, stewardship events and provides funding for campus ministry in the Presbytery.

Church Revitalization & Development Ministry \$18,000

The Church Revitalization & Development Ministry discerns opportunities for new worshipping communities and functions to assist current congregations in pastors in the areas of church growth and evangelism. The CRD offers assistance with the New Beginnings program to churches. The CRD hosted the Transformation Conference with Rev. Dr. Ann Philbrick in August. In March, the CRD will host "The Missional Church-Simple Conference" with Ray Jones in Winchester.

Commission on Preparation for Ministry \$7,000

The Commission on Preparation for Ministry fulfills the functions related to the process of nurturing Inquirers and Candidates for Ordination as Teaching Elders, including assistance in vocational discernment and guidance in the policies and procedures of the PC(USA) and the Presbytery.

Commission on Representation \$200

The Commission on Representation is charged with the responsibility of Nominating. The COR nominates to the Presbytery a Moderator, a Vice-Moderator and a Treasurer, members of the standing Commissions, the Chairs and Vice-Chairs of all the Commissions and Ministries, members at large of the CC, Commissioners to other councils of the church, and representatives to boards and agencies. The COR advises the Coordinating Commission with respect to its membership and the membership of all Presbytery Commissions and Ministries, groups, and entities, including boards and agencies, to ensure fair and effective representation in the decision making bodies of the Presbytery.

Congregational Issues Commission \$2,000

The Congregational Issues Commission assists congregations with any difficult issues that arise, including conflictual situations and complaints involving the actions of teaching and ruling elders.

Coordinating Commission \$11,000

The Coordinating Commission sets forth mission directions, goals, objectives and priorities as it is guided by the Presbytery's Mission Statement, regularly reviews the Presbytery's Mission Statement, coordinates the work of the Presbytery between its meetings and ensures that the decisions made by the Presbytery are carried out.

Leadership Development Ministry \$10,000

The Leadership Development Ministry oversees the content and schedule of Leadership Development for the Presbytery. The Leadership Development Ministry looks at issues of conflict management, leadership, organizational change, and the need for adaptive change process. This group is tasked with the training, oversight and continued education of Commissioned Ruling Elders. It works with newly ordained clergy and pastors new to the Presbytery, and is in the process of developing a coaching program for clergy. The Leadership Development Ministry provides opportunities for Sexual Misconduct Prevention Training to insure that all Teaching Elders and employees are trained every five years.

Mission Ministry \$10,000

The Mission Ministry provides resources and training for congregations to educate and inform them about mission opportunities within the local community and worldwide. The ministry strives to connect congregations within the Presbytery who may have common mission interests and goals; promotes and inform congregations of denominational special offerings and programs for mission; coordinates mission initiatives within or beyond the Presbytery, in particular in times of disaster and difficulty, so that the particular contributions of the Presbytery's congregations can more efficiently be distributed and then reported and shared throughout the Presbytery. The ministry provides opportunities for congregations to apply annually for hunger and peacemaking grants. Besides the use of unified funds that are provided, the Mission Ministry is also able to provide grants to our congregations by using designated contributions to hunger and peacemaking each year. In 2017, grants were issued using \$30,750 of designated and unified mission funds. These grants supported projects such as Chapel Hill's "Gainesway Homework Huddle", Danville's "Grace Café, Ezel's "Loaves and Fishes", First Georgetown's "Amen House", First London's "Food Pantry", Second's "Canaan House". "A Cup of Joe" and Westminster Village programs, and Backpack Ministries in Ashland, Isom. Midway and Versailles. Peacemaking grants were also awarded to Ashland's "Ashland Area Presbyterian Ministries," First Georgetown's "Summer Reading Program," Second's "Nonviolence Initiative," and Wilmore's "Clean Cupboard" program.

Pastoral Transitions Commission \$20,000

The Pastoral Transitions Commission shepherds a congregation from the moment a pastoral leader decides to leave, is removed from office or retires until a new leader is formally installed. This commission works with the Session to determine the best course of action for a congregation searching for new, permanent leadership, including all the various steps of the PNC process including examining and receiving the new Teaching Elder/CRE, approving any Interim contracts and new terms of call. The design of this commission is to create a "turn-key" process to ease the burden and eliminate the confusion and lower the anxiety for congregations in transition.

Other Support \$14,000

Presbyterian Women \$3,000

The Presbytery provides support to Transylvania's Presbyterian Women Group. The PW affirms women's calls to leadership and serves as a link between Presbyterian Women in the Congregation and Presbyterian Women in the Synod, implements a yearly program, supports the mission of the Presbyterian Church (U.S.A.) worldwide through education, interpretation and global awareness.


Kentucky Council of Churches \$4,000

The Kentucky Council of Churches is an organization made up of sixteen Christian traditions: one family of faith in the Commonwealth of Kentucky since 1865.

Presbytery Meetings \$7,000

The Presbytery meeting is a primary mechanism for communication and connection. We strive to facilitate necessary business in a time-effective manner, using good process, limiting business to an appropriately minimal amount of time, during which items needing action are presented, discussed, and put up for a vote. We strive to build relationships across neighborhoods at presbytery gatherings, enhancing these through intentional conversations and activities. The Presbytery celebrates the Eucharist at every meeting and shares a meal and a time for fellowship and conversation. Our current custom is to worship together at each presbytery meeting with a focus on Spirit-filled, Christ-centered worship. Occasionally, speakers, who can lead us in worship and provide leadership development through workshops and seminars is provided at presbytery meetings.

Final Report from the Nicholasville Presbyterian Church Administrative Commission

After 197 years of faithful ministry in and around Jessamine County, on September 24, 2017, the Nicholasville Presbyterian Church held its final worship service. This report to Transylvania Presbytery is the final act of the Administrative Commission appointed to oversee the dissolution of this congregation. After meetings with the session, the pastor, and as a commission, the following actions were taken by the Administrative Commission in line with their charge:

- A. Attempt to locate any official records of the church and turn them over to the Stated Clerk of the Presbytery for proper preservation:
 - All historic church records have been sent to Columbia to be archived and current financial records have been turned over to the presbytery
- B. After consulting with the Trustees of Presbytery (Administration), terminate the church's current lease (renewal date of Sep 30, 2017) and dispose of any church property, excluding funds from the sale of the Nicholasville Church property;
 - Historic items (including the Font, Table, pulpit Bible, Communion set, and pictures and records of local interest) were donated to the Jessamine County Historical Society. If at any time another PC(USA) congregation is formed in Jessamine County, these items can be retrieved for the use of that congregation;
 - Worship and education items (including pulpit, pew Bibles, hymnals, Communion table cloth, curriculum, and choir music) were donated to local churches;
 - Craft supplies, children's musical instruments, and an Ellison Die Cut Machine were given to local schools;
 - -The handbells were given to a children's handbell choir
 - Other items (including tables, chairs, a refrigerator, a freezer, pictures, books, etc.) were given to church members, church neighbors, the Wilmore High-Bridge Community Service Center, and Goodwill
- C. Arrange for transfer of members to other congregations;
 - Using the most recent membership roster 47 members were contacted. Those who have responded have been transferred.
- D. Prepare a service of recognition of the life and ministry of the Nicholasville Presbyterian Church;
 - The Rev. Greg Kupar held this service on September 24, 2017. And the congregation will be recognized at the November 11, 2017, presbytery meeting.
- E. Recommend to the Presbytery at its November 11, 2017, meeting a plan for the best use of the remaining assets of the Nicholasville Presbyterian Church;
 - See below for recommendation
- F. Dissolve the pastoral relationship between the Rev. Gregory Kupar and the Nicholasville Presbyterian Church and negotiate a severance agreement.

- The pastoral relationship between the Rev. Gregory Kupar and the Nicholasville Presbyterian Church was dissolved on September 30, 2017. Pastor Kupar's severance package included: 6 months housing and salary, 1 year of pension and medical dues, and a week of interim pastor training. The severance will end when/if the Rev. Kupar receives another call during this time frame.

RECOMMENDATION from the COMMISSION:

The Administrative Commission appointed to dissolve the Nicholasville Presbyterian Church recommends that the remaining Nicholasville Presbyterian Church Redevelopment funds shall be used to strengthen and further the PC(USA) witness in Jessamine County. If by January of 2019 no ministry opportunity has presented itself in the Nicholsaville/ Jessamine County area, the presbytery may consider using a portion of these funds to contract with a church consultant to do a formal study assessing the needs of Jessamine County to help identify the best use of the remaining funds for strengthening and furthering the Presbyterian presence and witness in the county. When a ministry opportunity presents itself, the Coordinating Commission in consultation with the Administration Commission, shall lead the discernment of said opportunity and oversee the dispersal of funds.

Mission Ministry

Report to Presbytery

November 2017

The Mission Ministry of the Transylvania Presbytery is undergoing some changes. Many members of our presbytery are interested in social action but are also the ones who are serving their churches and communities in many other ways and can't make meetings.

The Mission Ministry is currently focusing on immigration issues. We will be posting information through Across the Woods and the information, or links, will be posted on the website. We encourage you to check there periodically so that you can be aware of issues in our communities and actions you might take to help "welcome the stranger". Gun violence and payday lender information is already on the website. Our next issue to consider will be voter suppression.

Mission Outreach...

...grant requests for 2018 were reviewed Oct. 23, 2017, and will be announced at the November meeting. Our requests were fewer than last year and money for funding was also less than last year. This year, the funds we had were given to hunger and peacemaking programs. We are happy to say that we were able to fund many of the grants at the amount that was requested.

...a majority of grantees replied, as requested, with information regarding their programs and how the grant monies were being used. These were published in Across the Woods, one at a time. Members of the presbytery reported on how much they enjoyed reading these reports. Most of us had no idea of what was being done through our churches.

Issue Advocacy

...due to the poor attendance at meetings, advocacy work could not be addressed by actual hands-on efforts.

...a small group visited Grace Café, a grant recipient, and had a wonderful experience learning more about this unique and very beneficial program addressing food needs.

...resources related to immigration issues will be posted weekly in Across the Woods. We believe that awareness will arise of areas where we could work to help ease the problems.

The Pastor Transitions Commission shepherds a congregation from the moment a Pastoral leader decides to leave, is removed from office or retires until a new leader is formally installed. This commission would be responsible for working with the Session to determine the best course of action for a congregation searching for new, *permanent* leadership, including all the various steps of the PNC process including examining and receiving the new Teaching Elder/CRE, approving any Interim contracts and new terms of call. They would also work on a suggested Installation Commission for the newly called Pastor. The design of this commission would be to create a "turn-key" process to ease the burden, eliminate the confusion and lower the anxiety for congregations in transition. They would also recommend Presbytery minimum terms of call each year after a thorough evaluation of national and local salary trends. This commission shall appoint moderators to Sessions of churches with leadership vacancies due to the search process and other duties assigned by the Presbytery or Coordinating Commission.
