#### Minutes of the Stated Meeting of the Presbytery of Transylvania Second Presbyterian Church, Lexington, KY March 13, 2018

#### **Convening of Presbytery**

The stated meeting of the Presbytery of Transylvania met at Second Presbyterian Church, Lexington, KY, on Tuesday, March 13, 2018. A quorum was present. Moderator David Hoskins called the meeting to order at 10:00 AM and led the opening prayer.

#### **Opening Business**

The roll of attendance for this meeting was formed. (see Appendix A)

#### Summary attendance:

The Stated Clerk moved the docket. Docket approved. First-time commissioners and other guests were recognized. Teaching elder Thomas Groome brought greetings from the host church. General Presbyter Philip Lotspeich informed the body of teaching elders who have left the presbytery and/or taken new calls.

The Stated Clerk moved the consent agenda: a) Stated Clerk's report, with recommendations to approve requests for excused absences; approve the minutes of the November 11, 2017, annual meeting; approve resolutions honoring the centennial anniversary of the Anna C. Brush Memorial Church and bicentennial anniversary of the First Presbyterian Church, Millersburg; accept resignations of teaching elder Laura McKnight from Permanent Judicial Commission and ruling elder Cathy Wilson from Pastoral Transitions b) Necrology Report c) Leadership Development Ministry Report; d) KY Council of Churches Delegate Reports; e) Christian Formation Ministry Report f) Presbytery 2017 Statistics Report g) Commission on Congregational Issues Report h) Synod of Living Waters Commissioners' Report i) Church Closing/Dismissals Commission Report. Motion passed.

#### **Decision Agenda**

#### **Coordinating Commission**

Chair Linda Maconochie reported. The commission recommended changes to the Manual of Operations. Motion passed. Linda called on teaching elder John White to explain the new liaison system being instituted among the churches of the presbytery.

#### **Pastoral Transitions Commission**

Chair Lisa Eye reported and shared details of the commission's work with pastors and churches in transition. Commission moved that the following installation commission be named to install the Rev. David Crawford at 2:30 PM on March 18, 2018, as pastor of First Presbyterian Church, Lawrenceburg, KY: ruling elders William Reed, Cindy Shyrock, and David Hoskins; and teaching elders Philip Lotspeich, Steven Pace, and Keith Benze. Motion passed.

#### Presbyterian Women

Karen May reported and encouraged women in local churches across the presbytery to become involved in the work of Presbyterian Women. Upcoming events include a Spring Gathering on Saturday, April 21, 2018, at Cynthiana Presbyterian Church and the Churchwide Gathering of Presbyterian Women, August 2-5, 2018, in Louisville, KY.

#### **POINT Report**

Ginny Baker reported and shared ideas for curriculum and resources for Christian education in local congregations. Ginny also highlighted new resources that will be available soon.

#### **Burnamwood Report**

Camp Director Robby Lear reported, providing an update of camp events over the winter season, plans for the spring and summer camping seasons, encouraged donors to support a Continued Giving Campaign, and invited everyone to an open house event on May 19, 2018.

#### **Church Development and Revitalization**

Chair Jay Mumper reported and informed the presbytery of an educational event in our Presbytery.

#### Order of the Day

At 11:00, the Order of the Day was called and the Presbytery prepared for worship. Worship included Proclamation of the Word, the Sacrament of Communion, and the commissioning of General Assembly commissioners. An offering (\$754) was taken

to support Louisville Presbyterian Theological Seminary students. After worship, the Presbytery recessed for lunch and the moderator called the meeting to order at 1:15 PM.

#### Living Waters for the World

Philip Lotspeich reported and shared his recent experiences traveling to Mexico to observe water installations, learn of the economic impact of clean water, and interact with local mission partners.

#### **Commission on Preparation for Ministry**

Chair Wanda Olive reported. The commission recommended that inquirer Heather McIntyre be moved to candidacy. The floor was opened for questions and the Presbytery heard from Ms. McIntyre her sense of call and a report of her studies and preparation thus far. A motion was made to sustain the examination and move the inquirer to the candidacy phase. Motion passed. The moderator asked the constitutional questions and spoke prayers.

#### **Mission Ministry**

Chair Greg Kupar reported and informed the Presbytery of a ministry meeting being planned for Saturday, April 7, 2018, at the Ezel Presbyterian Church in Ezel, KY.

#### **Administration Commission**

Chair Curtis Christian reported. The commission recommended that the First Presbyterian Church of Stanton, KY, be dismissed to the Evangelical Presbyterian Church as outlined in the Dismissal Agreement. After discussion, motion passed. The moderator called on General Presbyter Philip Lotspeich to lead the Presbytery in prayer.

#### General Presbyter

The General Presbyter offered his report. Opening remarks included a reminder of the November meeting, which will be a combined meeting of three Kentucky presbyteries. The General Presbyter addressed the transitions facing our churches and Presbytery and offered words of hope that we might move faithfully from complacency to a firm conviction that we are doing God's ministry of making new disciples and trust in God's abundance.

#### Minute for Mission

Teaching elder Caitlin Foehse informed the body of upcoming Holy Week services in the Lexington area and invited everyone to attend.

#### **New Business**

At 2:40 PM, there being no new business before the Presbytery, the Stated Clerk moved that the Presbytery stand adjourned until its next stated meeting on Saturday, August 11, 2018 at 10 AM. Motion passed. The Moderator spoke a closing prayer and the Presbytery adjourned.

# Leadership Development Ministry

The Leadership Development Ministry met February 15. 2018.

#### We discussed:

- 1. Exploring a different online training system for sexual misconduct prevention. In addition, we hope to have a training event at the August 11 presbytery meeting, pending approval by the Coordinating Commission.
- 2. Requesting sample "safe child" policies and staff policies regarding sexual misconduct among adults, to distribute to our congregations and leaders.
- 3. Recruiting new members to join our ministry.
- 4. Beginning an educational series for church leaders: Ministry in Changing Times. We plan on having the first course in October of this year. More information will be available after a planning session.

We submitted to the Coordinating Commission suggested changes for the Manual of Operations, regarding sexual misconduct prevention training.

Re: Kentucky Council of Churches, 70<sup>th</sup> Annual Assembly October 19 and 20, 2017, Jeffersontown Christian Church, Louisville, Kentucky: "Unpacking Power & Privilege."

Dear Jerry and Robyn:

I apologize for this late report.

This was my first Kentucky Council of Churches Annual Assembly as a delegate from the Presbytery of Transylvania. It was an honor to be asked to represent the Presbytery of Transylvania, made easier because I spent most of the meeting with Rev. Mike Ward, Rev. Susan Warren and Lawrence Monroe. At one point, Phillip Lotspeich came over to encourage us to move around and get to know other delegates, which did happen during our break-out sessions for workshops.

I have attended prior KCC Annual Assemblies as a member of the Creation Care committee. I have also been a friend and supporter of Nancy Jo Kemper, growing out of the proximity of Pisgah Presbyterian Church and New Union.

This meeting was my introduction to Rev. Donald Gillett, II, and I was very impressed with his passion and his advocacy.

The theme of the Assembly was "Unpacking Power and Privilege." The two keynote speakers were both very powerful and very eloquent advocates. On Thursday, Mr. Jack Jezreel, founder of JustFaith Ministries spoke about "Missionary Discipleship" and made the clear distinction between "providing answers" and sending checks at the problem as opposed to building relationships outside our comfort zone. He said wealth is a problem because it often traces back to an abuse – that privilege is not a blessing, it is a curse because it makes you blind. And that Jesus was a road guy, not a sanctuary guy.

I attended the "Environmental Privilege" workshop sponsored by the Creation Care committee and the "House Divided" workshop led by the Kentucky Rural-Urban Exchange.

The Friday keynote speaker was amazing with a very troubling message. Rev. Dr. Miguel De La Torre discussed his book, *Embracing Hopelessness*. He said "hope" was damaging and dangerous to people of color. He noted that the Spanish word for "hope" comes from the word "waiting" and that Christian "hope" has been used to defend systems of European-Caucasian power over people of color. "Hope domesticates the oppressed." He disagreed with Martin Luther King – the arc of history does not bend toward justice – at least not on its own. "We have to bend it. It won't do it by itself." Some of us white male Caucasians felt the punch.

Finally, BreadfortheWorld lead another powerful exercise on laws and policies enacted by white men that have contributed to wealth and land acquisition by white people and loss of wealth and land by people of color, starting after the Civil War with Andrew Johnson's land policies and sharecropping (1865-1880).

Again, thank you for the opportunity to represent the Presbytery.

The Administrative Commission also would be empowered to take actions on behalf of the session of First Presbyterian Church, Pikeville if this is necessary in the judgment of the Administrative Commission. This would take place if, after meeting with the session, the Administrative Commission determines that the session is unwilling/unable to take the actions deemed necessary by the Administrative Commission.

# Annual Meeting of the Synod of Living Waters January 29, 2018 by Transylvania Voting Delegates Karen Hartsfield and Mary Weber

One of the highlights of the Jan. 29 meeting was hearing from covenant partners. President Dr. Cynthia Warrick of Stillman College briefly reviewed the college's history, including the fact that Presbyterian Women in 1920 financed construction of the oldest building on the Tuscaloosa, AL, campus. She mentioned the need for one more board members, whom she would love to come from Presbyterian Women. Later in the Synod meeting Presbyterian Women's Synod moderator Nancy Bryson touchingly volunteered herself and future Synod PW moderators to serve on Stillman's board.

Patrick Noltemeyer, Chief Planning Officer and Special Assistant to the President of Centre College in Danville, KY, updated the Synod. Among the many highlights of his report he said that 85 percent of Centre's students graduate and 80 percent participate in volunteer activities. Fifty percent of the student body are Kentuckians.

Columbia Theological Seminary's Julie Bailey, who is Director of Alumni and Church Relations at the Decatur, GA, institution, invited Synod members to consider the question of how to most effectively support alumni once they've been out of seminary for one to five years, and to let her know your answers.

Brian Alderman, Chaplain and Associate Professor of Philosophy and Religion at King University in Bristol, TN, expressed a passion for Christ and fidelity to Presbyterian heritage.

Maryville College's Kathleen Farnham, Director of Church Relations for the Maryville, TN, institution, noted the approach of the college's 200<sup>th</sup> anniversary of instilling Presbyterian values. The college is sponsoring a breakfast on June 20<sup>th</sup> at the upcoming General Assembly. Breakfast will be at 8 a.m. and will cost \$15 per person.

Synod Moderator of Presbyterian Women, Nancy Bryson, reported that the next Synod Triennial of Presbyterian Women will be June 13-15, 2019 in Jackson, MS with a church-wide Gathering Aug. 2-5, 2018 in Louisville, KY.

Another highlight was Living Waters For the World's report in which Director Steve Young expressed gratitude to Mary Weber and all Presbyterian Women for their creative fund-raising of making and selling crocheted necklaces. \$52,000 has been raised to date through this project. An inspiring, child-focused youtube.com video, "Clean Water for All God's Children," is now available to share with anyone interested in participating or giving.

William McConnell, Presbyterian Mission Agency, reported that \$12 million has been received this year for Presbyterian Disaster Assistance which helps after hurricanes, fires and other devastating events.

Synod training of commissioners and delegates to the General Assembly will take place April 29 and 30 in Franklin TN.

An overture regarding nuclear non-proliferation was sent to a Synod committee to enable the fullest consideration and participation.

Moderator Ruling Elder Leonard Jordan (Mid TN Presby) and Vice Moderator Rev. Tom Lovell (North Alabama Presby)were duly elected.

#### Church Closings and Dismissals Commission Report to Presbytery of Transylvania March 13, 2018

The Church Closings and Dismissals Commission has met two times (November 27, 2017, and January 19, 2018).

The first meeting served as an organizational meeting and identification of priority tasks. The commission members discussed current Presbytery policies and developing best practices regarding the closure or dismissal of churches.

At its second meeting, the commission:

Reviewed the work of naming priorities and identifying current needs.

A task force was formed to negotiate the terms of dismissal for the First Presbyterian Church, Stanton.

Having received a request from the congregation, a task force was formed to negotiate the closure of the Chapel Hill Presbyterian Church.

A follow-up letter will be sent to the First Presbyterian Church, Booneville, and Indian Creek, Booneville, seeking to set up a meeting to engage their requests to separate themselves from the Presbyterian Church (U.S.A.).

# Coordinating Commission Report to Presbytery March 13, 2018

Since the November Presbytery meeting, the Coordinating Commission met four times: December 12, 2017; February 2-3, 2018 (planning retreat); February 20, 2018; and February 28, 2018 (teleconference).

#### Actions Taken by the Coordinating Commission:

Nominated the Rev. Schuyler Olt as Transylvania representative to USpiritus Board

Named a task force composed of ruling elder David Hoskins, Corbin PC; ruling elder Marsha Banks, Graham Memorial PC, Whitesburg; teaching elder Curtis Christian, First PC, Richmond; and teaching elder Philip Lotspeich, General Presbyter (ex-officio), to inquire into and settle the reported difficulties of the First Presbyterian Church, Pikeville, KY. [reference: BOO G-3.0109(5)]

Reviewed the actions of the Closing Commission and Administration Commission concerning the dismissal of the First Presbyterian Church, Stanton, to the Evangelical Presbyterian Church. (Motion for Presbytery consideration will come from the Administration Commission.)

#### TRANSYLVANIA PRESBYTERY

#### **Manual of Operations**

#### A Manual of Administrative Operations for the Presbytery of Transylvania

#### 1. Commissions of the Presbytery

#### 1.1 General Provisions for Commissions of the Presbytery

- A. Members of the Commissions of the Presbytery shall consist of both teaching elders and ruling elders, with the Presbytery seeking to uphold as closely as possible an equal balance with particular attention to diversity in representation.
- B. Members shall be elected at the final Presbytery meeting of the year and shall assume office in the next calendar year.
- C. Terms of office shall ordinarily be three years. Members shall be eligible for reelection for a second three-year term but thereafter shall not be eligible for reelection until one year has elapsed. In cases where the member is appointed to fill an unexpired term, if the term to be filled be for one year or less, the person filling the unexpired term shall be eligible for two full terms on his/her own, with total eligibility not to exceed seven (7) years. If the unexpired term be for more than one year, the appointee shall be eligible for but one full term of his/her own.
- D. The Chair of each Commission shall be nominated by the Commission on Representation (COR) and elected by the Presbytery at the annual meeting, to take the office in the next calendar year.
- E. In addition to the Coordinating Commission, the following are the standing Commissions of the Presbytery:

Administrative
Burnamwood
Closing Commission
Congregational Issues Commission
Pastoral Transitions Commission
Permanent Judicial (PJC)
Preparation for Ministry (CPM)
Representation (COR)

#### 1.2 Administrative Commission

The Administrative Commission shall be composed of six members. Its duties shall include serving as the Trustees of the Presbytery and having responsibility for Accounting, Budgeting, and Staff Services. The Treasurer of the Presbytery shall serve as an advisory member with voice and without vote.

#### A. Witness (Trustees)

The Administrative Commission shall serve as Trustees for and on behalf of the Presbytery of Transylvania, Inc., a religious corporation. The Corporation shall elect the Process Agent, who is responsible for performance of the duties prescribed by the laws of the Commonwealth of Kentucky with reference to corporations. The Stated Clerk fills this office and shall also serve as Process Agent for the Trustees. The Trustees are empowered to receive, to hold, to encumber, to manage, and to transfer property, real or personal, for the Presbytery; to accept and to execute deeds of title to such property; to hold and to defend title to such property; to manage any permanent special funds for the furtherance of the purposes of the church, when authorized to do so by the Presbytery. It is the duty of the Trustees to facilitate the management of the civil affairs of the Presbytery in keeping with the laws of the Commonwealth of Kentucky. The Trustees shall report to the Presbytery as necessary or as requested and shall function in accord with the *Book of Order*, G-4.02.

#### **B.** Nurture (Staff Services)

The Commission shall be responsible for supervision of the staff of the Presbytery in accordance with G-3.0110. When there are staff vacancies, it shall recommend to Presbytery the process by which the General Presbyter is recruited, called and hired, and to the Coordinating Commission the process by which all other staff are recruited, called and hired. It shall conduct annual performance reviews and evaluations and five-year comprehensive reviews. It shall make recommendations concerning matters related to the Presbytery staff to the CC or to the Presbytery as circumstances determine. The Commission shall provide and maintain for the Presbytery approved Personnel Policies, including a position description for all Presbytery employees.

#### C. Serve (Accounting, Budgeting)

The Commission shall obtain budget recommendations from the appropriate Commissions and Ministries of the Presbytery and develop, propose, and monitor, in consultation with the Treasurer, the Presbytery Budget, incorporate the total financial functions of the Presbytery under one single administration; maintain and supervise a single and unified accounting system subject to an annual outside audit and a simple, all inclusive financial statement whereby a comprehensive picture of the whole mission of the Presbytery can be seen.

#### 1.3 Burnamwood Commission

The Burnamwood Commission shall be composed of 9 members divided into three classes. The Commission shall be responsible for oversight of the Burnamwood Camp and Conference Center, including Development and Awareness (fund development, publicity, and promotion); Program (oversight of summer camping, retreats and conferences); and Site Management (maintenance and improvement of the site).

#### 1.4 Closing Commission

The Closing Commission shall be composed of five members. The Closing Commission shall counsel with congregations that have indicated their desire to end their relationship with the Presbyterian Church (U.S.A.) or those that have reached the completion of their effective ministry. This commission shall receive referrals from the Presbytery, the Commission on Congregational Issues or the Coordinating Commission. This commission shall determine a course of action, either division, dismissal, or dissolution, negotiate the terms of such action, and recommend it to the Presbytery for final approval. Such negotiations include consultation with the Administrative (Trustees) Commission.

#### 1.5 Congregational Issues Commission

- The Congregational Issues Commission shall be composed of six members, divided into three classes.
- The Congregational Issues Commission will work with congregations that need assistance in dealing with concerns related to congregational life that are not conflict situations, but for which outside consultation might be helpful. This commission will work closely with the Leadership Development Ministry to help focus resources on congregational health and vitality.
- The commission will work closely with the Pastoral Transitions Commission if issues arise in congregations with temporary pastors or congregations that are in transition.
- This commission will assist congregations with any difficult issues that arise, including conflictual situations and complaints involving the actions of teaching and ruling elders. Installed teaching elders may initiate a request for assistance from the commission; ruling elders and congregation members also may contact the commission for assistance.
- Formal complaints that rise to the level of a disciplinary case will not be handled by this commission, but will be referred to the Presbytery's Permanent Judicial Commission.
- The commission will also undertake other responsibilities as assigned by the Presbytery or Coordinating Commission. This commission may recruit, seek additional help and build teams with people not on the commission for short-term projects when necessary.

#### 1.6 Pastoral Transitions Commission

The Pastoral Transitions Commission shall be composed of nine members divided into three classes. The Pastoral Transitions Commission will shepherd a congregation from the moment a Pastoral leader decides to leave, is removed from office or retires until a new leader is formally installed. This commission is responsible for working with the Session to determine the best course of action for a congregation searching for new, *permanent* leadership, including all the various steps of the PNC process including examining and receiving the new

teaching elder/CRE, approving any Interim contracts and new terms of call. The Commission will also work on a suggested Installation Commission for the newly called Pastor. The design of this commission is to create a "turn-key" process to ease the burden, eliminate the confusion and lower the anxiety for congregations in transition. The Commission recommends Presbytery minimum terms of call each year after a thorough evaluation of national and local salary trends. This commission shall appoint moderators to Sessions of churches with leadership vacancies due to the search process and other duties assigned by the Presbytery or Coordinating Commission. This commission may recruit, seek additional help, and build teams with people not on the commission for short-term projects when necessary. This Commission has the authority to receive and dismiss teaching elders and receive candidates who have been certified to receive a call (pending their successful examination on the floor of the presbytery); the authority to approve calls, or changes in calls, when they are found to be in order, and to appoint commissions to ordain and/or install; the authority to dissolve pastoral relationships in cases where the teaching elder and congregation concur; the authority to grant the status of Honorably Retired; the authority to approve validated ministries and confer upon teaching elders the status of member-atlarge; the authority to counsel with a local church session and approve the election of a Pastor Nominating Committee; the authority to grant permission to a local congregation to circulate a Ministry Information Form.

#### 1.7 Permanent Judicial Commission (PJC)

In accordance with D-5, the Presbytery shall elect, by nomination from the COR, a Permanent Judicial Commission, as outlined in the *Book of Order*, D-5.0000.

#### 1.8 Commission on Preparation for Ministry (CPM)

In accordance with G-3.0307, the Presbytery designates a Commission on Preparation for Ministry (CPM) that shall be composed of twelve members. The Commission shall fulfill the functions related to the process of preparation for ordination as teaching elder as set forth in G-2.06 and shall provide for the training and nurture of ruling elders who apply to become Commissioned Ruling Elders (CREs). To this end, the work of CPM includes:

#### A. Witness

In its work with Inquirers and Candidates, the Commission shall be directed by the resources and guidance of General Assembly agencies in consultation with the Office of the General Assembly. The Commission may recommend to the Presbytery for its approval particular standards and processes that facilitate the discernment of call and the preparation of persons for ordained or commissioned ministry.

The Commission shall have authority to enroll Inquirers and dismiss Candidates to other presbyteries, with all such actions being reported to the next stated meeting of the Presbytery.

#### B. Nurture

The Commission shall be responsible for the recruitment and training components of the CRE Program, in keeping with the provisions of G-2.10 and in accordance with the policies approved by the Presbytery.

The CPM shall nurture Inquirers and Candidates for Ordination as teaching elders and/or commissioning as Commissioned Ruling Elders, including assistance in vocational discernment and guidance in the policies and procedures of the PC(USA) and the Presbytery.

#### C. Serve

The CPM shall elect teaching and ruling elders to serve as readers for ordination examinations.

#### 1.9 Commission on Representation (COR)

The Commission on Representation shall be composed of six members who shall be nominated by the CC and elected by the Presbytery. It is tasked with an intentional purpose: to ensure the church's commitment to inclusiveness and the principles of unity and diversity (per G-3.0103). To this end, the work of COR includes:

#### A. Witness

COR is charged with the responsibility of Nominating. COR shall nominate to the Presbytery a Moderator, a Vice-Moderator and a Treasurer, members of the standing Commissions, the Chairs and Vice-Chairs of all the Commissions and Ministries, members at large of the CC, Commissioners to other councils of the church, and representatives to boards and agencies. Ordinarily, the list of nominees shall be presented for election at the annual meeting of the Presbytery.

#### **B.** Nurture

COR shall advise the CC with respect to its membership and the membership of all Presbytery Commissions and Ministries, groups, and entities, including boards and agencies, to ensure fair and effective representation in the decision-making bodies of the Presbytery.

#### C. Serve

The Chair of a Commission or Ministry shall report to the Stated Clerk, who shall report to the Chair of COR, concerning mid-term vacancies. This may be due to a resignation, or vacancy due to lack of participation. Should any commission or ministry member miss three consecutive meetings, and after personal contact from the ministry or commission chair, the absences shall constitute a resignation and the commission or ministry chair shall submit the resignation to the Stated Clerk. COR is charged with recommending to the CC the appointment of a temporary replacement until elections to fill vacancies can be held at the next meeting of the

Presbytery.

#### 2. Ministries of the Presbytery

#### 2.1 General Provisions for Ministries of the Presbytery

A. Each Ministry of the Presbytery shall have control over its budget as approved by the Presbytery.

B. A Chair and Vice-Chair (one being a teaching elder, the other being a ruling elder) shall be elected by the Presbytery to a 3-year term. The Chair and Vice-Chair may appoint additional members as needed for the mission of the particular Ministry, seeking to uphold parity between teaching elders and members of congregations and honoring the full diversity of the Presbytery in representation.

C. Ministries of the Presbytery currently include:

Christian Formation
Church Revitalization and Development
Leadership Development
Mission

#### 2.2 Christian Formation Ministry

This Ministry shall be responsible for coordinating the Presbytery's work in strengthening and supporting congregations in their faithful discipleship through Biblical and theological knowledge, a commitment to stewardship, and spiritual formation. To this end:

#### A. Witness

The Ministry will focus on areas of mission including youth, young adults and campus ministry, continuing education, stewardship, and discipleship and spiritual formation within congregations.

The Ministry will celebrate and support the established events and programs of the Presbytery that inform Christian formation among and within the Presbytery's congregations, as well as build on these offerings.

#### **B.** Nurture

The Ministry will encourage the use and sharing of resources within the Presbytery. The Ministry will inform congregations of denominational and other resources that are available that may prove useful in endeavors to strengthen and deepen the discipleship and *caritas* of members in the congregations of the Presbytery.

#### C. Serve

The Ministry shall receive, discern, and respond to needs for the training of leaders, including teachers, officers, youth, etc,

The Ministry will work with congregations and the whole Presbytery to provide appropriate events for instruction and growth in the fullness of spiritual development and Christian living for members of all ages.

The Ministry will seek to develop events and programs specifically designed for youth, as well as promote wider denominational youth events, and it will work with

local congregations to develop youth leadership and more programming.

The Ministry shall work with the Administrative Commission in interpreting to the congregations the work of the Presbytery and encouraging congregations in their connection to the Presbytery, Synod, and General Assembly through prayer, service, and the sharing of resources (per capita apportionment, Unified Mission Giving, Special Offerings, and other avenues) to build up the ministry of Jesus Christ as witnessed in and through the larger church.

#### 2.3 Church Revitalization and Development Ministry

The Church Revitalization and Development Ministry exists to work with current churches engaging in revitalization and transformation efforts and to promote and encourage the development of new worshiping communities.

#### 2.4 Leadership Development Ministry

The Leadership Development Ministry oversees the content and schedule of Leadership Development for the Presbytery. While there is overlap with the area of Spiritual Christian Formation, this group would look at issues of conflict management, leadership, organizational change, and the need for adaptive change process. This group would be tasked with the training, oversight and continued education of Commissioned Ruling Elders. This group ey would also work with newly ordained clergy, Pastors new to the Presbytery and consider developing a coaching program for clergy.

This group would provide Sexual Misconduct Prevention Training at regular intervals to insure that all teaching elders and employees of Transylvania Presbytery, and any volunteers under the supervision of Transylvania Presbytery, including officers, those serving on its Commissions and Ministries, boards and support of its programs, may be trained every five years.

This group would provide Sexual Misconduct Prevention training at regular intervals to insure that all teaching elders, Presbytery employees, commissioned ruling elders, and chairs/co-chairs of commissions and ministries may be trained at least every five years. These trainings, whether in person or on-line shall also be offered and available to any volunteers under the supervision of the Presbytery.

#### 2.5 Mission Ministry

The Mission Ministry shall seek to strengthen and support congregations in their mission to their communities and to the world, and to assist in coordinating mission opportunities within the Presbytery. To that end, the ministry:

#### A. Witness

Shall endeavor to ascertain what mission is happening in and through the congregations of the Presbytery and help to communicate that information and opportunities for service throughout the Presbytery.

#### **B.** Nurture

Shall respond to resources and training for congregations to educate and inform them about mission opportunities within the local community and worldwide.

Shall strive to connect congregations within the Presbytery who may have common mission interests and goals.

Shall promote and inform congregations of denominational special offerings and programs for mission.

May coordinate mission initiatives within or beyond the Presbytery, in particular in times of disaster and difficulty, so that the particular contributions of the Presbytery's congregations can more efficiently be distributed and then reported and shared throughout the Presbytery.

Shall support existing congregations by offering resources for transformation and redevelopment for the strengthening of the congregation, i.e., building and program needs.

#### C. Serve

Shall support the congregations of the Presbytery and their mission work by offering a wide variety of resources and channeling resources of the Synod and the General Assembly to local congregations.

Shall be responsible for supporting the work of congregations and the Presbytery as they witness to the love of Jesus Christ by feeding the hungry, sheltering the poor and homeless, welcoming the stranger, encouraging the care and protection of God's creation, and promoting social justice.

Shall discern opportunities for new worshipping communities, and be responsible for developing new worshipping communities and missions, including the development of new congregations, site acquisitions and pastoral leadership.

Shall function to equip and train congregations and pastors in evangelism and church growth.

## Missional Discipleship "Following Jesus into the lives of Our Neighbors"

Objective: Participants will demonstrate how transforming discipleship leads to mission in their

particular context.

- Jesus invested in His early followers so they would go where He intended to go. **Their lives were** *transformed* by His life, and they were sent out to bear witness to this new life in Christ.
- By the power of the Holy Spirit, they joined Jesus' ministry of healing the sick, welcoming the stranger, and walking with the marginalized. In North America, discipleship is often understood as receiving information that will improve one's spiritual life.
- Many North American Christians understand discipleship as their "church" experience, which is separate from and has little influence on the rest of their lives. Therefore, discipleship is disconnected from mission. Luke 10:1-10 will be used as a platform to discover how discipleship is connected to mission in the community through a Neighborhood Exegesis.

The venue will consist of 3 inter-active workshops.

#### WORKSHOP #1

A time to share with one another about our own experience of the transforming love of God and how this experience impacts our ministry.

#### WORKSHOP #2

A time to experience what it means that the church is a "sending" body. We are equipped to do ministry. All of us will look at the practices that equip us for God's mission.

#### WORKSHOP #3

A time to discern what God is already doing in our neighborhoods and how best to join God's mission.

During 2017 Living Waters for the World (LWW) continued with its goal of working toward the day when there will be clean water for all God's children. Highlights included.

- 1. 40 clean water systems, installed by LWW trained teams, have reached 10 years of service.
- 2. A group of eight traveled to Ghana in September to begin the process of creating a Clean Water U in Ghana.
- 3. 39 new Clean Water systems were installed by LWW trained teams. (a few more may yet be entered on the database). This represents a slight decline from recent years reflecting an increased emphasis on sustainability.
- 4. While it maintains a strong relationship with the Synod of Living Waters, LWW has become a separate 501c3 nonprofit corporation. The hope is this will help attract donations from some foundations that will not fund organizations that are strictly church entities.
- 5. Perhaps the highlight for the year for Transylvania was the fact that Philip Lotspeich began service on the LWW board of directors. Joanie Lukins completed her service on that board and also retired as leader of the LWW Yucatán network.
- 6. Joanie was recently honored by our Mexican partners in a ceremony in the village of Kaua, during the annual operator's conference.

The Transylvania team rehabbed a system in the village of Oxcabal last July. That team will be installing a system near the town of Champoton in July. This will be a one week trip with an approximate cost of \$800 per person plus airfare. Participation on that team is open to all. The necklace program, headed by Mary Weber, continues to raise a few thousand dollars a year for LWW.

# Preliminary Statement of Faith (Heather McIntyre)

"In life and in death, we belong to God." I believe that the Triune God who is our Creator, Redeemer, and Sustainer calls each of us to seek justice and reconciliation in a sin-filled world. When we seek to know and obey God's Word, follow Christ's example, and listen to the Holy Spirit, we help proclaim that the Kingdom of God is at hand.

God's love is unfathomable. In the beginning, the Father created all things, pronounced them good, and tasked us with caring for Creation.<sup>2</sup> As a result of our sinful nature, we continually fail to live up to this duty. Denying our interconnectedness and turning away from God's precepts, we injure our planet, harm one another, and worship the false gods of material gain and power. These decisions fill the Holy One with sorrow and anger. Nevertheless, God continues to call us to repent of our sinful self-interest and seeks to gather us in as a mother hen gathers her children under her wings.<sup>3</sup> God's protection of the people of Israel and messages through the prophets demonstrate the Holy One's special care for those who are downtrodden. As the psalmist says, God "executes justice for the oppressed...The LORD sets the prisoners free, the LORD opens the eyes of the blind. The LORD lifts up those who are bowed down; the LORD loves the righteous. The LORD watches over the strangers; he upholds the orphan and the widow." As children of the Living God, we are called show our thanks for the free gift of God's grace by doing justice, loving kindness, and walking humbly with our God. I believe that when we answer this call, we reflect God's love and help bring about reconciliation for all Creation.

I believe that God's love and mercy are perfectly revealed to us in the life, death, and resurrection of God's son Jesus Christ, who is the way, the truth, and the life.<sup>6</sup> Proclaiming that the Kingdom of God is at hand,<sup>7</sup> Christ demonstrates through both words and deeds that God cares for the marginalized, lifts up the downtrodden, and upsets the principalities of this world. Christ invites each of us to witness to the coming Kingdom by becoming disciples and following him. In his willingness to follow God's call to the point of condemnation and death, Christ shows the depths of God's love and challenges us to seek justice, mercy, and reconciliation even at the expense of our own safety and security—to take the cross and follow him.<sup>8</sup> Christ's resurrection attests that nothing—not the powers and principalities of this world, not sin, not even death—can separate us from God's love or prevent the coming of God's Kingdom.

Like those who have gone before us, we are called to help usher in God's perfect kingdom—an existence in which we are reconciled with God and one another. As the giver and renewer of our faith, The Holy Spirit, (God's gift through grace) enables us as both individuals and the Church to listen to God's call. The Holy Spirit helps us turn our hearts back to God and show our thanks by worshipping God, loving one another, and seeking to end all injustice. It "gives us courage to pray without ceasing, to witness among all peoples to Christ as Lord and Savior, to unmask idolatries in church and culture, to hear the voices of peoples long silenced, and to work with others for justice, freedom, and peace." Although I—like all the faithful—live into God's call imperfectly and sometimes stumble along the road to salvation, I rest assured that God's grace is sufficient and that God's purpose for myself and for all Creation will prevail. # Report to Presbytery Administration Commission/Trustees/Treasurer's Report March 13, 2018

#### **Recommendation to Presbytery:**

The First Presbyterian Church of Stanton has requested dismissal from the PCUSA to the Evangelical Presbyterian Church. Over the past year, the Congregational Issues Commission and the Closing Commission have worked with the church on the various issues involved in order to dismiss the church. The Administration Commission reviewed the work of the previous presbytery commissions and recommends to presbytery that the First Presbyterian Church of Stanton be dismissed to the Evangelical Presbyterian Church as outlined in the attached Dismissal Agreement.

#### **AGREEMENT OF DISMISSAL**

KNOW ALL MEN BY THESE PRESENTS the parties listed below do enter into this AGREEMENT OF DISMISSAL.

WITNESSETH the party of the first part, First Presbyterian Church, an Association in Stanton, Kentucky and the parties of the second part, Presbyterian Church USA (PCUSA), Synod of the Living Waters and the Transylvania Presbytery of Kentucky and all acts being confirmed by the respective representatives with attached signatures below do hereby enter into this **AGREEMENT OF DISMISSAL** this \_\_\_\_\_ day of \_\_\_\_\_, 2018.

The party of the first part having requested, pursuant to the Book of Order, to be dismissed from the PCUSA and its respective subdivisions and the parties of the second part, being represented by a Closing Commission from the Transylvania Presbytery, have agreed to the following terms and conditions for the dismissal of the First Presbyterian Church, Stanton to the Evangelical Presbyterian Church.

#### TERMS AND CONDITIONS

These terms and conditions of the AGREEMENT OF DISMISSAL shall be recorded in the Powell County Court Clerk's Office in the Miscellaneous Book.

This Agreement of Dismissal will be referenced in a Deed setting out the terms, conditions, recitals and stipulations that will affect various claims and interests of property located in Stanton, Powell County, Kentucky which is the place of worship for the party of the first part.

The parties are aware there is potential litigation over the ownership rights and interests of the real and personal property. In conformity with the Book of Order, and in an effort to avoid prolonged litigation, the parties of the first part and the parties of the second part do hereby agree to the following terms, conditions, recitals and stipulations.

- 1. The party of the first part have voted overwhelmingly to be dismissed from the parties of the second part to Evangelical Presbyterian Church. The Evangelical Presbyterian Church has confirmed with both parties they are willing and have accepted the party of the first part into the Evangelical Presbyterian Church.
- 2. The parties of the second part being PCUSA, the Synod of Living Waters and the Transylvania Presbytery will sign and execute all deeds tendered to them for the purpose of extinguishing any and all claims which they may have and quitclaim all interest to the real property which is the subject of this agreement upon fulfillment of the terms set forth herein.
- 3. The total consideration for the parties of the second part quitclaiming all interest they may have to real property occupied by the party of the first part shall be as follows: The party of the first part, shall, for a period not to exceed ten (10) years but be no less than five (5) years, pay to the parties of the second part sixty-five thousand dollars (\$65,000.00) in no less than six-thousand five-hundred dollar (\$6,500.00) increments for the ten (10) year period. Upon the fifth anniversary date of the signing and execution of this document, if so desired by the party of the first part, the party of the first part may pay the balance which is owed of the sixty-five thousand dollars (\$65,000.00), complying

with and satisfying all the provisions of this paragraph. This provision is to be considered a lease purchase for the interest the parties of the second part may have in land which is the current place of worship for the party of the first part.

- 4. Of the aforementioned consideration, thirty-five thousand dollars (\$35,000) shall go to the general fund of the Transylvania Presbytery as renumeration for unpaid per capita assessments due and owing from the party of the first part. The balance of the consideration shall be utilized by the Transylvania Presbytery to further the ministry of Camp Burnamwood, or any similar or successor youth ministry, that Transylvania Presbytery may approve at its sole discretion.
- 5. The party of the second part shall have a right of reversion to the party of the first part for a period of ten (10) years which is inclusive of that term of years which is stated in the previous numerical paragraph three (3). The right of transfer shall terminate on the ten (10) year anniversary date of the signing and execution of this document, so long as all terms set forth herein have been met.
- 6. The right of reversion will only inure to the benefit of the parties of the second part in the event the Evangelical Presbyterian Church dismisses the party of the first part, without the party of the first part going into and being accepted by another reformed denomination. If the Evangelical Presbyterian Church releases the party of the first part to another reformed denomination then no reversion would occur.
- 7. The party of the first part shall obtain liability insurance in an amount sufficient to indemnify and hold harmless the parties of the second part. Any insurance obtained, indemnifying and holding harmless the parties of the second part, shall only be

for the purposes of liability. The party of the first part will obtain insurance for property damage and destruction due to fire loss or other catastrophic event. The party of the first part shall be the sole recipient and beneficiary of any and all proceeds of this policy. This paragraph is only to be in affect so long as the parties of the second part have not been fully paid the sixty-five thousand dollars (\$65,000.00) due from the party of the first part. Upon the payment in full of the sixty-five thousand dollars (\$65,000.00), the party of the first part has no obligation to obtain insurance listing the parties of the second part as additional insureds.

- 8. Any improvements to the subject property, would be included and transferred to the parties of the second part in the event of a reversion within the ten (10) year period. The parties of the second part will agree to sign any and all documents which are necessary for the purpose of collateralizing the property within the ten (10) year period. The party of the second part shall not be responsible for any debt or expenses related to said collateralization, except to the extent the property would stand as collateral and security for any indebtedness, loan or mortgage on said property. The remaining balance of the monies owed the parties of the second part under this agreement shall act as a superior claim to any further collateralization and shall not be subregated to such.
- 9. Upon the tenth (10<sup>th</sup>) anniversary of the signing and execution of this document, and upon the fulfillment of all terms contained herein, the right of reversion would cease to exist and the parties of the second part would have no claim whatsoever, to the realty or the improvements thereon. Further, beginning on the date of the signing

and execution of this agreement, the parties of the second part will have no claim to any personalty, of any kind and nature, including but not limited too all bank accounts, vehicles, moveable or intangible property, which are in the name of the party of the first part.

This agreement and the provisions contained herein shall apply to, bind, and inure to the benefit to all successors, legal representatives and assigns.

This is the full and exclusive agreement of the First Presbyterian Church, Stanton, the party of the first part and PCUSA, the Synod of Living Waters and the Transylvania Presbytery, the parties of the second part. The individuals as Trustees and Elders on behalf of the party of the first part have signed solely in their capacity as the representatives of First Presbyterian Church, Stanton. Further, the signatures on behalf of the Transylvania Presbytery, the Synod of the Living Waters and PCUSA are attached and affixed hereto, by persons in their representative capacity as the Board of Trustees with the authority to bind the parties of the second part.

This agreement represents the entire agreement between the parties. This agreement may not be changed, amended, altered or modified except by written document and consent of all parties.

#### Notes from Treasurer's Report

#### Operating Budget

- 1. Total Revenue as of 12/31/17 is \$391,963 as compared to \$421,502 at 12/31/16. This is a decrease in revenue of \$29,538.
- 2. Total Expense as of 12/31/17 is \$437,140 as compared to \$482,380 at 12/31/16. This is a decrease of expense of \$45,240.
- 3. Total Net for the operating budget as of 12/31/17 is (\$45,177) as compared to (\$60,879) at 12/31/16. The 2017 Budget that was approved by Presbytery projected a deficit of (\$51,995).
- 4. General Reserves of \$45,177 were used to balance the shortfall.

#### Burnamwood Budget

- 1. Total Burnamwood revenue as of 12/31/17 is \$197,420 as compared to \$212,891 at 12/31/16. This is a decrease of revenue of \$15,471.
- 2. Total Burnamwood expense as of 12/31/17 is \$210,289 as compared to \$239,644 at 12/31/16. This is a decrease in expense of \$29,355.
- 3. Total Net for Burnamwood as of 12/31/17 is (\$12,870) as compared to (\$26,753) at 12/31/16.
- 4. Unified dollars of \$75,000 were budgeted and used for the Burnamwood budget in 2017. An additional \$12,870 was used from General Reserves to balance the shortfall.
- A per capita and unified giving spreadsheet by church as requested by Presbytery is attached.

#### Actions Taken by Administration Commission since November presbytery meeting:

- 1. Year-to-date financial reports as of December 31, 2017 were reviewed and approved including reserves, foundation accounts, unified mission and per capita contributions.
- 2. Approved \$10,000 from the Emergency Grant Designated Fund for Pisgah Presbyterian Church in Versailles due to the sudden death of their pastor, Michael Bush.
- 3. Worked with the Coordinating Commission to setup a Stewardship Task Group to develop a year-round stewardship program for the presbytery. The task group members are Curtis Christian, Anne Chesnut, Woody Berry, Katie Busroe and David Hoskins.
- 4. Approved a motion to discontinue monthly withdrawals from the Nicholasville Redevelopment Fund.
