Since the last presbytery meeting, the Coordinating Commission has met two times: June 15, 2021, and July 20, 2021.

Actions taken by the commission:

- Moved the date of the August presbytery meeting to Saturday, August 14, 2021, at Lexington Korean Presbyterian Church.
- Accepted the resignation of presbytery treasurer Sara Benedetti. (Sara has taken a new call to New Jersey.)
- Approved a request by Commission on Preparation for Ministry to celebrate the Sacrament of Communion at their annual retreat for inquirers and candidates, to be held on Saturday, August 28, 2021, at Beaumont Presbyterian Church, Lexington, KY.

Report to Presbytery Treasurer's Report/Administration Commission/Trustees August 14, 2021

Information to Presbytery:

- The Treasurer's Report as of June 30, 2021 is attached.
- On May 25, 2021, Anita Clemons from the Presbyterian Foundation reviewed the presbytery's investment accounts with the foundation and discussed various investment strategies.

Notes from Treasurer's Report

Operating Budget

- 1. Total Revenue as of 6/30/21 is \$141,303 as compared to \$160,209 at 6/30/20. This is a decrease in revenue of \$18,906.
- 2. Presbytery Unified Giving as of 6/30/21 is \$51,740 as compared to \$56,129 at 6/30/20. This is a decrease in revenue of \$4,390.
- 3. Presbytery Per Capita as of 6/30/21 is \$47,807 as compared to \$44,670 at 6/30/20. This is an increase in revenue of \$3,137.
- 4. Total Personnel as of 6/30/21 is \$109,893 as compared to \$113,482 at 6/30/20. This is a decrease in expense of \$3,589.
- 5. Total Committee Expense as of 6/30/21 is \$36,416 as compared to \$46,800 at 6/30/20. This is a decrease in expense of \$10,384.
- 6. Total Expense as of 6/30/21 is \$160,029 as compared to \$176,424 at 6/30/20. This is a decrease in expense of \$16,395.
- 7. Total Net for the operating budget as of 6/30/21 is (\$18,726) as compared to (\$16,215) at 6/30/20.

Burnamwood

- 1. Total Burnamwood revenue as of 6/30/21 is \$45,758 as compared to \$32,746 at 6/30/20. This is an increase in revenue of \$13,012.
- 2. Total Burnamwood expense as of 6/30/21 is \$67,511 as compared to \$51,261 at 6/30/20. This is an increase in expense of \$16,250.
- 3. Total Facilities expense as of 6/30/21 is \$46,786 as compared to \$30,342 at 6/30/20. This is an increase in expense of \$16,444. This increase is due to a water leak repair and the breakdown of the heat and air unit in Mount Lodge. Repairs have been completed.
- 4. Total Net for Burnamwood as of 6/30/21 is (\$21,753) as compared to (\$18,516) at 6/30/20.

Actions Taken by Administration Commission since May presbytery meeting

- 1. Financial reports as of June 30, 2021 were reviewed and approved including reserves, foundation accounts, unified mission and per capita contributions.
- 2. Correspondence was received from the Augusta and Sharon Presbyterian Churches in September 2020 seeking permission to sell the manse at 107 East Fourth Street, Augusta, Kentucky. At that time, the Commission requested a copy of an appraisal and a proposed sale price of the property. The Commission received the information needed and approved the sale of the property for the offered price of \$110,000.
- 3. In May 2019, Presbytery dissolved the First Presbyterian Church of Pineville. Administration approved a motion to begin the process to sell the church building and vacant lot. An appraisal is in process.
- 4. On October 22, 2020, at the request of the United Presbyterian Church of Harrodsburg, the Commission approved a motion to sale the property at 101 Mooreland Ave., Harrodsburg, Kentucky (known as the Academy Building) without the normally required appraisal. The sale of the property fell through. The Church received a new offer of \$265,000 and an appraisal was done on the property. A motion was made and seconded to approve the sale of the property for the offered price of \$265,000.
- 5. The Nicholasville Ministry project had year-to-date expenses totaling \$18,794.45 as of May 31, 2021 that has been paid out of the Chase Bank operating account. A motion was approved to make a withdrawal from the Nicholasville Redevelopment Foundation Account of \$18,794.45 to replenish the operating fund for these expenditures.

Leadership Development Ministry

Leadership Development Ministry met on Tuesday, August 27, 2021. Those present were: Beth Garrod-Logsdon (chair), Melissa Sevier (vice-chair), Mary Reed, Sarah J. Wilson, and Philip Lotspeich. Not in attendance: John Leggett and Josh Akers.

Melissa Sevier updated the ministry team on the new Commissioned Pastor (formerly Commissioned Ruling Elder) training. We currently have four persons interested in beginning the training which is targeted to begin this fall. If you are a ruling elder interested in this training or would like more information, please contact Melissa or one of the other members of Leadership Development Ministry listed above.

The bulk of our meeting time was focused on the task of updating the presbytery's Sexual Misconduct Prevention Policy. We have read and researched policies from several other presbyteries and are planning to present a newly rewritten policy to our presbytery by year's end.

As part of our current Sexual Misconduct Prevention Policy, every member of presbytery, presbytery staff, and commissions and ministries are required to have sexual misconduct prevention and boundary training every five years. We will be offering this training in October and again in the spring. We will be notifying those in the presbytery who are nearing (or have passed) the five year mark.

Church Closings/Dismissals Commission Presbytery of Transylvania August 14, 2021

The commission met at on Thursday, July 15, 2021, at First Presbyterian Church, Winchester, KY, and Thursday, July 29, 2021, at Old Springfield Presbyterian Church, Owingsville, KY.

- The commission recommends that, at the request of the remaining members, the Hull Memorial Presbyterian Church, Hazard, KY, be dissolved; that its records be secured and sent to the Presbyterian Historical Society in Philadelphia, PA; that the Closing and Dismissals Commission and Administration Commission work together to bring a proposed disposition of the church building and lot to a future meeting of the Presbytery.
- The commission recommends that the Old Springfield Presbyterian Church be dissolved; that its records be secured and sent to the Presbyterian Historical Society in Philadelphia, PA; that the Closing and Dismissals Commission meet with interested parties to determine the best course of action to further the ministry of the Old Springfield community and historic cemetery and transfer the church property in light of these discussions.

For Presbytery Information:

- The commission continues to work with churches that have requested dissolution or dismissal.
- The commission will work to engage churches that have not participated in presbytery functions and seek to reengage them with the presbytery's fellowship and mission.
